Armstrong Issues Executive Order Establishing North Dakota Interagency Council On Homelessness

Governor Kelly Armstrong last week issued an executive order establishing the North Dakota Interagency Council on Homelessness to coordinate relationships among state agencies and homelessness service providers and develop strategies and best practices for preventing and ending homelessness in

"While North Dakota already has a strong network of support services and programs for those experiencing homelessness, we still have individuals falling through the cracks," Armstrong said. "The Interagency Council on Homelessness will provide a forum for state agencies and service providers to gather information and community input, identify areas for improvement, and recommend strategies to wipe out homelessness and prevent its underlying causes."

North Dakota Housing Finance Agency (NDHFA) Executive Director Brandon Dettlaff will chair the 12-person Council, and Commissioner of Recovery & Reentry Jonathan Holth will serve as vice-chair. The other members include four Cabinet leaders and six members appointed by the governor: North Dakota Indian Affairs Commission Executive Director Brad Hawk; North Dakota Department of Corrections and Rehabilitation Director Colby Braun; North Dakota Department of Commerce Commissioner Chris Schilken; North Dakota Department of Health and Human Services Interim Commissioner Pat Traynor; Chandler Esslinger, chair of the North Dakota Coalition for Homeless People; Shawnel Willer, NDH-FA Continuum of Care coordinator; Bryce Meyer, The Waters Sober Living Homes and executive pastor of operations at Evangel church in Bismarck; Curtis Regan, associate broker and real estate developer at Dakota Commercial in Grand Forks; Bismarck City Administrator Jason Tomanek; and Louise Dardis, longtime West Fargo Public Schools educator and principal, board member of YWCA Cass Clay.

The panel will report annually on its progress in preventing and ending homelessness in North Dakota, including recommendations for executive and legislative action.

Armstrong also has proclaimed this week, November 16-22, as Hunger and Homelessness Awareness Week in the State of North Dakota. The proclamation can be viewed on-

ND Stockmen's Association Seedstock **Council Webinar To Focus On Bull Fertility**

Bull fertility will be the focus of the featured presentation during the North Dakota Stockmen's Association (NDSA) Seedstock Council Virtual Webinar at 6:30 p.m. November 20. The Seedstock Council hosts a free, educational webinar via Zoom each fall for seedstock producers and their customers.

This year's webinar will aim to answer the question, "Why do some bulls get cows pregnant more efficiently?" and provide other reports. Dr. Lacey Quail, North Dakota State University livestock management Extension specialist, and Dr. Saulo Zoca, University of Tennessee assistant professor and Extension beef cattle specialist, will tag-team the feature presentation, exploring the key factors driving bull fertility, the role of semen quality and the new tools helping develop fertility

Quail is originally from eastern South Dakota, where she grew up raising sheep and cattle. As a graduate student, her research focused on the role of estradiol in pregnancy maintenance in beef cattle, as well as improving reproductive efficiency and profitability of beef operations through the use of reproductive technologies. In her current role at the North Central Research Extension Center, she develops and delivers livestock management programs across North Dakota while collaborating with Extension specialists and agents, research faculty, livestock organizations and produc-

Zoca's work focuses on advancing reproductive efficiency in beef cattle by integrating applied and translational research with producer-driven Extension. His work has examined bull fertility from multiple angles, including the identifica-tion of sperm proteins and metabolites associated with fertility, the use of proteomics and flow cytometry to predict reproductive outcomes and the impacts of nutrition, management and herd health on pregnancy establishment and loss.

Senate Passes FY2026 Agriculture **Appropriations Bill**

Senator John Hoeven issued the following statement after the Senate passed the Fiscal Year (FY) 2026 agriculture funding bill. As chairman of the Senate Agriculture Appropriations Committee, Hoeven worked to negotiate and secure the legislation's passage as part of a package to re-open the federal government. This follows Hoeven's efforts to author the bill and ensure it provides strong support for farmers and ranchers, agriculture research and rural America.

"We advanced this year's agriculture funding legislation through regular order, showing that we can support our priorities and find savings to reduce the debt and deficit, while securing bipartisan support both in committee and on the Senate floor. That's the right way to approach our appropriations work, and this agreement to re-open government helps us get that process moving again," said Hoeven. "Importantly, we worked to ensure our ag funding legislation supports the innovative research being conducted by NDSU, Grand Farm and their partners. At the same time, this bill supports better access to credit and the services our producers rely on at FSA. This is important not only as harvest wraps up, but as we work to advance an ag assistance bill to provide a bridge to help producers until the new reference prices come into

Dakota Gardener: A Little Nudge

As far as I'm concerned, it's been

gorgeous fall. The trees put on a great color show and then dropped their leaves in showers of yellow, red, gold and

Around here, they're mostly yel-

Some of the lilacs were a bit weird, though. They flowered or sent out some small leaves. It was just a few shrubs, but they shouldn't be blooming in the fall.

This year's wet weather created perfect conditions for a foliar fungus called Pseudocercospora. Lilacs around the state got hammered by this disease. The shrubs lost their leaves early and went into a dormant state. When moderate fall temperatures arrived, some of them flow-

To help the lilacs, all we can do at this point is rake and destroy the leaves as best we can. We can hope that next year will be drier, but that one's out of our hands.

Trees and shrubs usually prepare themselves for winter just fine. They store up energy in late summer and fall, and gradually harden off for

But we can help here, too. Watering conifers late into the fall helps them get hydrated. That's important for minimizing "winter injury."

Winter injury can have a number of causes and isn't understood very well. Nevertheless, getting trees hydrated before winter is key to managing this issue.

Late-fall watering isn't as critical

conifers. Perhaps the most important winter prep I do relates to my archenemies, rabbits.

Rabbits, and voles, kill more trees each winter than cold temperatures do. The animals eat the bark from younger trees, especially fruit trees, to get the sugar-rich phloem tissue just below the bark.

If a tree loses bark all the way around its circumference, it's as good as dead. I've lost a number of apple trees over the years, and I've begun to take some extreme mea-

White plastic pipes and wraps do a good job of preventing this type of damage, but only as high as the pipe goes up the stem. When there's a lot of snow, these pests climb the drifts and girdle the branches. What took years to develop can be gone in one

It's frustrating.

I've now taken to putting a wire fence around my apple trees. It's a bit of a project to set this up, but the fence is really effective against rabbits... as long as there are no major snow drifts. And if I set up the fence far enough from the tree trunk, the deer will be held back, too. I'll do what I can and hope for

the best. I can't control nature. The best I can do is try to give it a little

ND Department Of Commerce Opens Automation Tax Credit Program Portal

The North Dakota Department of Commerce recently announced that the Automation Tax Credit (ATC) Program Portal is now open for applications. The program supports North Dakota primary sector businesses investing in automation that enhances productivity, efficiency and competitiveness across manufacturing and animal agricultural

The Automation Tax Credit, authorized under N.D.C.C. § 57-38-01.41, allows eligible taxpayers to receive an income tax credit for the purchase or capital lease of machinery and equipment used to automate manufacturing or animal agricultural processes in North Dakota. The program provides a credit of up to fifteen percent of qualifying costs, with a total annual allocation of \$3 million and set-aside amounts for first-time claimants and animal agricultural processors.

New this year, all applications must be fully completed and submitted with all required supplemental documentation by 5 p.m. CT on January 31, 2026.

Applications requiring additional clarification will be granted a single seven-business-day window to provide the necessary information for reconsideration. If the requested information is not submitted within that timeframe, the affected invoice line items will be denied.

Incomplete applications will be deemed ineligible and will not be

Applicants are encouraged to allow up to three working days to receive a portal invitation before beginning the application.

To qualify, applicants must: Be certified as a primary sector business by Commerce.

• Demonstrate that the automation investment adds value, improves job quality or increases output. For example, through at least a five percent increase in wages, safety or production.

• Ensure that the automation or robotic equipment is located and operated within North Dakota.

Completed applications, including Supplement A and all supporting documentation, must be submitted through the Automation Tax Credit Program Portal by the deadline.
