**August 26th, 2025, Steele County Commission Meeting**  
The Steele County Commission meeting was called to order at 8:15 a.m. Commissioners Brandon Oxtan, Perry Brown, Brandon Krueger, Richard Strand, and Chris Grandalen were present, as was Auditor Jana Flaten, DES Manager Ben Gates, Reed Oien, Interstate Engineering Engineers Mike Bassingthwaite and Tyler Bircherm.  
Mike and Ben gave a brief background on the flex funding, how the money will be distributed, and the September deadline. They then discussed what the county should apply for. Reed had gone out and talked with township officers to explain the program, and with the help of Interstate Engineering, they would need to apply for their own projects. The county discussed cost-sharing and agreed to 90/10. It was also noted that a list of culverts and bridges will be updated to ensure that the county and townships clearly distinguish between township and county-owned bridges and culverts. There was also a brief discussion about pavement projects with this program, and that it would be at least a 6–10-year project, as the state would only fund portions of the project at a time and would not always be approved for the money to fund the project.  
Tyler discussed the townships and what they have reached out with on their lists. Hugo, Edendale, Melrose, Newburgh, and Beaver Creek had all expressed interest in


bridge/culvert projects.  
Mike, Tyler, and Ben will collaborate with the townships to work on the list and applications for the state.  
Mike and Tyler will gather county information and start the application process. They will bring that information to the September meeting.  
en brought the architect's contract to the commissioners; he asked them to accept it so they could start working on the scope for the courthouse while it is nice out. Commissioner Krueger made a motion to accept Bartlett West contract, seconded by Commissioner Grandalen. There was no further discussion, and all members voted aye. The motion carried.

Reed Oien updated the board on the new dike/dam that Fugleberg would like to have installed by Jacobson. The drain/culvert previously discussed with the commissioners and SC Water District is scheduled to be placed by the county in September, with Interstate Engineering there on the day it is installed. The commissioners want to make sure that Fugleberg is taking proper steps with the Water District, and the county doesn't want anything done with the County right of way, which is 65 feet on both sides from the center line. Commissioner Strand moved to approve Fugleburg's request if it complies with Sc Water and County right way, seconded by Commissioner Brown. There was no further discussion, and all members voted aye. The motion carried.  
Oien gave a gravel update: KRB is done, and the county and Lakeside are still working and plan to get done soon. Chip seal will start on August 18th.  
Ben Gates reviewed the flex fund and grants for townships, bridges, and county items. Tyler Bircherm with Interstate Engineering was on via Zoom and went over the bridge list and the plans for the next few weeks to get the paperwork and the list to the state by the end of August. Reed and Interstate Engineering plan to get the paperwork together and meet with township officers to review items for the flex funding. There will be a special meeting on August 26th at 8:15 a.m. to review the township's findings and finish the paperwork.  
The Budget hearing is scheduled for September 4th at 7:00 p.m. Correction: the budget hearing needs to be held after September 7th. The new date is September 9th at 8:00 a.m., and a regular commission meeting will follow.  
Wildlife Explorer members came to discuss the addition of a Rainbow bridge on the courthouse side lawn. This will be a bridge for anyone to use and a place to remember lost pets. They hope to finish it by the end of

August and will continue to upkeep the bridge throughout the years. Commissioner Brown made a motion to approve the bridge, seconded by Commissioner Grandalen. There was no further discussion, and all members voted aye. The motion carried.
