As far as complaints from users, the only one not being able to be fixed is the hard water sources that fill their systems. The goal is to “provide good quality water to all users”. Also noted was the amount of water demand that goes out for field use for farmers and the increased pressure needed.

Owner relations are a “priority for the board” as was remarked on the positive attitudes and actions of both staff and board in dealing with landowner issues. One instance was noted of a water line breakage due to another other business contractor digging a pit for their waste materials that fractured the MSRWD pipeline. The MSRWD responder to the scene had handled the entire conflict with appropriate professionalism and received compliments publicly on his work. The line was repaired with user use only briefly interrupted. There are now 800 miles of pipe in the system.

Photos of the new plant under construction were provided by Broussard, along with a report on the office staffing and other operational changes taking place. A three-stall garage is also planned to be added to the site as the project is completed.

Board members not mentioned include vice-president Jeff Walcker, Sheridan County Bulk Rep Walter Lipp, McLean County Director Jackson Hagen, Sheridan County Directors Terry Strobel and Luke Peterson.

The group enjoyed a complimentary light supper and the well-run meeting lasted only an hour or so before everyone was on their way home.
