"Participating in competitions like this makes it easier to present in class, talk to strangers, and talk about how I feel, allowing me to be confident in myself," shared McCormack.

Poetry Out Loud, sponsored by the National Endowment for the Arts and the Poetry Foundation, is a national program designed to encourage students to explore poetry through memorization, performance, and competition. Now in its 20th year, the program has engaged millions of students across the United States, offering resources such as lesson plans, an online anthology of over 1,200 poems, and opportunities to compete from local contests to the National Finals. At Nationals, winners receive substantial cash prizes, including \$20,000 for the champion.

While McCormack's journey in this year's competition ended at the state

As the second-place winner, McCormack received a trophy, medallion, and \$100. Wilton Public School was awarded \$200 to purchase poetry books for its library.

For McCormack, the competition was as much about personal growth as it was about performance.

"The most rewarding part of participating in Poetry Out Loud was being around a group of people who understood my passions and being able to share my voice with people who care," McCormack said. "I learned that you must put your whole self into anything you do, accepting the risks that come with it. Vulnerability is crucial to being fulfilled."
