Bottineau man named in fatal McLean County crash

Tioga woman injured in incident

A Bottineau man has been named as the person who died in a McLean County crash during the Thanksgiving Day weekend.

According to a press release issued Nov. 30 by North Dakota Highway Patrol Lt. Jenna Clawson Huibregtse, first responders were dispatched just before 5 p.m. Nov. 28 to the intersection of U.S. Highway 83 and N.D. Highway 37 on a report of a two-vehicle, T-bone crash.

Clawson Huibregtse stat-

ed Gordon Lindquist, 88, of Bottineau, was traveling eastbound in his 2007 Toyota Camry on N.D. Highway 37 as he approached U.S. Highway 83.

At that time, Liana Bachar, 32, of Tioga, was traveling southbound on U.S. Highway 83 in her 2025 Hyundai Santa Cruz.

According to Clawson Huibregtse, Lindquist came to a stop and entered the intersection where Bachar struck Lindquist on the driver's side. Bachar's vehicle came to a rest on the highway, while Lindquist's vehicle came to a rest in the

east ditch. Lindquist was pronounced dead at the scene, and Bachar was transported to CHI St. Alexius Health in Garrison.

The press release stated, at the time of the crash, the road conditions were icy and wet on top of windy and snowy weather conditions.

Assisting NDHP at the scene was the McLean County Sheriff's Office, ND Department of Transportation, Garrison Fire and Rescue, Max Fire and Rescue, Garrison Ambulance, Underwood Ambulance and White Shield Ambulance.

Nov. 8

Deputies performed a traffic stop at about 1 a.m. on U.S. Highway 83 southbound near mile marker 137 after it was reported by a third party there was a reckless driver all over the roadway before going down in a ditch and hitting something. Adam Harder, 23, of Durham, North Carolina, was arrested for driving under the influence and driving with a suspended license.

Deputies responded at about 2:30 a.m. to U.S. Highway 83 near mile marker 200 in Washburn for a motorist assist. It was reported a truck and trailer were hit by a Jeep near the Cenex intersection. During the investigation, the driver had admitted to drinking. Jarrett White Owl, 27, of New Town, was arrested for driving under the influence.

Nov. 10

Deputies performed a traffic stop at about 12:15 a.m. on U.S. Highway 83 near mile marker 133 after the vehicle failed to maintain lane of travel. As deputies approached the vehicle, they noted the driver and passenger switch seats. At first, one of the subjects gave a fake name, later stating they did it because their license was suspended. Deputies asked to search their vehicle, so deputies ran the K-9 officer unit around the

vehicle, prompting a search. Emily Bragg, 21, of Minot, was arrested for driving under suspension and giving false information. Armond Edmundson, 23, of Bismarck, was arrested for driving under suspension and cited for open container. Ramalla Hunt, 25, of Bismarck, was arrested for driving under suspension.

Nov. 11

Deputies responded at about 3:45 p.m. to Fort Stevenson on a report of criminal mischief. An off-duty deputy reported vandalism and theft from the state park in Garrison. Upon investigation, the state park had camera footage of damage being done to the men's bathroom Nov. 2. Along with damage done, it was reported Ryobi floor scrubber, batteries, chargers and other items were also taken from the park. Deputies are investigating the situation.
