

Wrestlers get road wins

BuccaDawg beat Holsteins, Beulah-Hazen

Bowman County/Beach wrestlers traveled to Beulah Jan. 3 and made the trip successful with wins over both Beulah-Hazen and New Salem-Almont.

Against one of the state's top wrestling programs, the BuccaDawgs swept four of the lighter weights and closed out the narrow 36-32 victory with a pair of wins at the heaviest weights.

Jace Boynton won his 107-pound match, then was followed by Gabe Sarsland (114), Silas Mark (121) and Cale Schwartz (127).

The Holsteins rallied, winning the 133-pound match and continued with victories at 139, 152, 160, 172 and 189. Only Dallas Jacobson's forfeit win at 152 pounds broke up the run.

In the last two matches, Jace Getz won at 215 pounds and Tucker Turbiville followed with a win by fall.

In the other dual contest, the BuccaDawgs got another win by a 40-30 margin.

Two of the victories for the BuccaDawgs in the lightest weights came by forfeit, while Boynton added to his list of conquests at 107 points.

In the middle weights, the BuccaDawgs got their winning edge with Ouradnik (139), Daniel Hoff (145), Isaiah Dobbs (152) and Sawyer Noll (160) notching victories.

Bowman County bounces Lady Rebels, 47-25

Bowman County bounced back into the win column Saturday, picking up a 47-25 victory on the road in Edgeley.

The Bulldogs jumped out to a quick 11-3 lead after one quarter and led by 21 points at halftime (30-9).

The visitors kept the lead in the second half, coasting to a 22-point victory margin.

Sophia Headley led the Bulldogs in scoring with 11 points, while Julie Sarsland added 10 points. Jordyn Honeyman finished the game with eight points and Kennedy Senn put

in five points. Raegan Stadheim scored three points. Five players – Adyson Gerbig, Landyn Gerbig, Teagan Homelvig, Livia Bowman and Cameron Mosbrucker – each got two points.

Elli Lloyd led the Rebels with 10 points, while Jaelyn Bertsch put in six and Betsy

Huber added four. Olivia Brummond and Ally Strobel each scored two. Maize Tjernlund put in one free throw.

Both teams hit 11 two-point baskets, but the Bulldogs had a seven treys edge in scoring from outside the arc for 21 of the 22-point victory margin.
