The Board of County Commissioners met in regular session on October 7, 2025, with the following present: Pine Abrahamson, Rick Braaten, Josh Buchmann, Jerid Janikowski and Nathan Miller. Chairman Braaten called the meeting to order at 9:00 AM. The Pledge of Allegiance was recited. Pastor Ed Kvaale shared a prayer. Braaten asked for corrections or additions to the agenda. Miller moved to approve the agenda. Abrahamson seconded the motion, and upon a vote, the motion was carried unanimously. The following October 7, 2025, vouchers were approved by a motion made by Miller, with Buchmann seconding the motion, and upon a vote, the motion was carried unanimously.

Abrahamson moved to approve the September 16, 2025, minutes with Janikowski seconding the motion, and upon a vote, the motion was carried unanimously.

Abrahamson moved to approve the September 2025 Month-End Bureau of Land Management Report, with Miller seconding the motion, and upon a vote, the motion was carried unanimously.

Bowman County Treasurer, Sydnee Kidd met to present the September 2025 Treasurer's Daily Cash Settlement/Bank Reconciliation Report. Janikowski moved to approve the report, Miller seconded the motion. A roll call vote was taken with all members voting yes. Motion carried.

Miller moved to approve the September 2025 Recorder and Sheriff Fee Collection Reports. Janikowski seconded the motion, and upon a vote, the motion was carried unanimously.

Discussion was held on the County Liquor License Resolution. Suggested changes were discussed. Auditor Schumacher will make the requested changes and present at October 21 meeting.

Buchmann moved to appoint Nicole Njos as the 2026 State Fair delegate for Bowman County. Abrahamson seconded the motion, and upon a vote, the motion was carried unanimously.

At 9:50 AM Chairman Braaten called the Unorganized Township Budget Hearing to order. Guests present: Jerry Jeffers, Pam Hestekin, Don Hestekin. Janikowski moved to keep the unorganized township mill levy at 7 mills. Miller seconded the motion. A roll call vote was taken with all members voting yes. Motion carried.

At 10 AM Chairman Braaten called the Public Hearing to order to receive public comments on the 2026 Budget. Guests present: Jerry Jeffers, Pam Hestekin, Don Hestekin, Mindy Dalley. Abrahamson moved to pledge \$7,000 to Theodore Roosevelt Expressway for 2026 from BLM funds. Janikowski seconded the motion. Roll call vote: Abrahamson, yes; Janikowski, yes; Buchmann, yes; Miller, no; Braaten, no. Motion carried. Discussion was held on the estimated county mill levies. Janikowski moved to approve the 2026 Final Budget, as presented, with Abrahamson seconding the motion. A roll call vote was taken with all members voting yes. Motion carried.

Brad Pauley, Sweetwater Golf Course, met to request funds for a new water well. Project cost is estimated to be \$29,600. Abrahamson moved to approve \$24,000 from BLM funds to go towards their water well project. Miller seconded the motion. A roll call vote was taken with all members voting yes. Motion carried.

Greg Gaub, Acting Manager, Little Missouri Special met with commissioners. Also present: Ryan DeMorrett and Craig Egeland. Discussion was held on moving a cattleguard where their solid waste program is located. It was decided they would add gates instead of moving the cattleguard.

Bowman County Highway Superintendent, Shane Biggs and Lucas Doerr, Brosz Engineering, met to discuss road projects. Discussion was held on the gravel crushing bid. Two bids were received. Miller moved to accept Alternate A, Class 13 low bid of \$365,700 from Fisher Sand & Gravel. Abrahamson seconded the motion. A roll call vote was taken with all members voting yes. Motion carried. Doerr presented the following Applications for payment: Application #6 from Steve Beylund Construction for \$95,186.83 for the Old Hwy 12 Reconstruction Project-

Phase 1, Application #1 from Wilson Construction for \$163,443.31 for the Whiskey Road Reconstruction Project, Application #2 from Wilson Construction for \$93,347.55 for the Divide Hill Reconstruction Project. Janikowski moved to approve Change Order #2 for the Divide Hill Reconstruction Project for an increase of \$7,200. Abrahamson seconded the motion. A roll call vote was taken with all members voting yes. Motion carried. Abrahamson moved to approve Change Order #2 for the Whiskey Road Reconstruction Project for an increase of \$6,600. Buchmann seconded the motion. A roll call was taken with all members voting yes. Motion carried. Janikowski moved to approve the Engagement for Legal Representation from Cooperative Legal Services. Miller seconded the motion. A roll call vote was taken with all members voting yes. Motion carried.

Discussion was held on the courthouse HVAC system. In addition to the proposal from TRANE, we have also received a proposal from Rasmussen Mechanical Services. We are currently waiting for one more proposal before making a decision.

The three resolutions for Theodore Roosevelt Expressway were discussed. Miller moved to approve the following resolutions.

A RESOLUTION SUPPORTING FUTURE INTERSTATE DESIGNATION FOR HEARTLAND EXPRESSWAY, THEODORE ROOSEVELT EXPRESSWAY, AND A PORTION OF PORTS-TO-PLAINS HIGH PRIORITY CORRIDORS AND NUMBERING FUTURE INTERSTATE SEGMENTS

WHEREAS, Congress has already designated the Heartland Expressway (14) in Colorado, Nebraska, Wyoming and South Dakota; Ports-to-Plains Corridor (38) in Oklahoma and Colorado; and the Theodore Roosevelt Expressway (56) in South Dakota, North Dakota, and Montana as a High Priority Corridors on the National Highway System; and WHEREAS, with Texas and New Mexico already designated as Future Interstate 27, this designation would move forward that effort to create a complete north-south corridor serving agriculture production, energy production, tourism, and international trade needs of not only the region, but also the nation; and WHEREAS, High Priority Corridors on the National Highway System were established in 1991 under Section 1105 of the Intermodal Surface Transportation Efficiency Act of 1991 (ISTEA) and amended several times since including the National Highway System Designation Act of 1995 which reaffirmed and refined the corridors, formally integrating them into the National Highway System and emphasized intermodal connections, national defense, and access to ports and border crossings; and the Infrastructure Investment and Jobs Act (IIJA), 2021, which amended several High Priority Corridors, reaffirming their importance in multimodal freight and economic corridors and encouraged use of these corridors in the development of rural infrastructure, Resilience Improvement Plans, and INFRA and RAISE grant funding; and WHEREAS, in FHWA Freight and NHS Policy Guidance cited in federal freight strategies for enhancing freight reliability, trade competitiveness, and infrastructure resilience; and WHEREAS, the purpose of the Interstate Highway System, formally known as the Dwight D. Eisenhower National System of Interstate and Defense Highways, is to provide a safe, efficient, and high-capacity roadway network for the movement of people and goods across the United States. It serves multiple national interests; and WHEREAS, the purpose of Future Interstate Highways is to expand and enhance the national transportation network by identifying and developing key corridors that will eventually meet full Interstate Highway standards, with the goal of supporting: 1) National Connectivity; 2) Freight and Economic Development; 3) Cross-Border
