# Southwest Water Authority board members recognized

Two members of the Southwest Water Authority (SWA) Board of Directors were honored with awards during the 61<sup>st</sup> annual Joint North Dakota Water Convention & Irrigation Workshop in Bismarck in December.

James Odermann, director for Billings County, received the Missouri River Joint Water Board Riverman Award. This accolade celebrates his leadership and resource management for the health of the Missouri River Corridor. Odermann's nearly three decades of service on the SWA board of directors have been pivotal in shaping the mission and operations of the Southwest Pipeline Project (SWPP) and SWA. A staunch advocate for rural water, Odermann was appointed by Governor Doug

Burgum in 2021 to represent the Little Missouri, Upper Heart, and Upper Cannonball River Basins on the North Dakota State Water Commission. His commitment to ensuring quality water access has been instrumental in developing sustainable water policies for the state.

Bruce Engelhardt, director for Morton County, was awarded the Commodore Award by Gov. Doug Burgum. This honor recognizes Engelhardt's exceptional leadership and dedication to North Dakota's water resources. Engelhardt's career spans 29 years of service with the North Dakota State Water Commission, where he made significant advancements in water management and development. Engelhardt held roles including Chief of the

Investigations Section and Director of the Water Development Division. His innovative and insightful leadership has left a legacy on North Dakota's water resources. Since retiring, Engelhardt continues to share his expertise through board service, contributing to the betterment of water resource management.

"The Southwest Water Authority is proud to celebrate the leadership of James Odermann and Bruce Engelhardt," said SWA Manager and CEO Jenifer Murray. ### NOTICE OF APPLICATION FOR APPROPRIATION OF WATER FROM SURFACE WATER

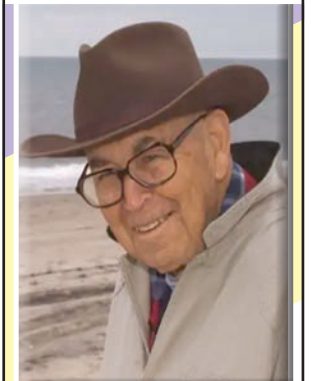
TAKE NOTICE that REIS, DAVID, FAIRFIELD, ND, has submitted Water Permit Application No. 7389 to the North Dakota Department of Water Resources for a permit to divert and appropriate water from Reis Pond.

The application requests to store 100.0 acre-feet of water with a total annual appropriation of 60.8 acre-feet of water, out of which 20.8 acre-feet will be used to offset evaporative losses, and 40.0 acre-feet of water will be used for Industrial use at a pumping rate of 7,000 gallons per minute, utilizing point(s) of diversion located in the NE1/4 of Section 22, Township 143 N., Range 098 W., Billings County.

TAKE NOTICE that written comments regarding the proposed appropriation must be filed in the Department of Water Resources, 1200 Memorial Highway, Bismarck, North Dakota 58504-5262, by 5 o'clock p.m., on the 3 day of February 2025. The Department of Water Resources shall consider all written comments received and prepare a recommended decision which will be provided to the applicant and any person who filed written comments. Those persons may file additional comments with the Department of Water Resources, request an adjudicative proceeding on the application, or both.
