DITCH MOWING NOTICE
The Grand Forks County Weed
Control Board, at the direction of
the Grand Forks County Commis-
sion, has determined that the control
of noxious weeds along all town-
ship roads has become a serious
problem. Accordingly, pursuant to
Grand Forks County and North Da-
kota state law, all township roadside
ditches must be mowed, by adjacent
landowners and/or operators, to a
height of no higher than 10 inches
and a width of 14 feet by Oct. 1,
2025.

mowed by the Grand Forks County
