### **CITY OF STANTON MEETING MINUTES**

Mayor Sayler called the city regular meeting to order at 6:30 p.m. at the City Hall with the following members present: Kelly, Babb. Neumiller and Cole. Present were Public Works Supervisor, Chapman, Public Works Personnel, Sailer, Auditor Braithwaite. Attorney Solem. Also present were guests K. Petti, J. Summers, S. Cole, B. Dunaway, DuMond, Library Board member, Olson and Librarian Assistant, K. Casson.

Moved by Babb, seconded by Kelly approving the minutes of June 23, 2025 City Council regular meetings. Roll call vote: All members voted aye, carried.

Mayor Sayler stated that he was contacted by the papers regarding the Library's decision, but he was unable to respond as he nor other council members were aware of the Library's situation.

Librarian Assistant, Casson, updated that the Stanton Library planned to purchase property owned by Boyko Investments in August. She stated that the property will be purchased with \$25000 donation from Union State Bank, \$2000 donations from adult prom and individuals, and \$23000 donation from R. Bovko. She requested that the city continue helping with snow removal and mowing which the council agreed. She also understood that the maintenance and other costs are the Library's responsibilities. Casson also informed the council that the Stanton Library is considering opening its own checking account. Auditor Braithwaite asked if they will be managing their own financials and will they want the library funds within the City to be transferred into their checking. Casson will check further with the Library Board for more information, Auditor Braithwaite also stated they will need to submit an annual financial report directly to the State, Attorney Solem asked Auditor Braithwaite to double check before moving forward. Auditor Braithwaite will contact the Library with more information. No action taken at this time.

K Petti asked the council about the Fireworks ordinance as she thought that the duration for fireworks was reduced to 4 days. Council informed her that the ordinance was reviewed earlier this year, and it was voted to make no changes as the set dates coincided with the selling of fireworks timeframe.

Moved by Neumiller, seconded by Cole approving the second reading for Midco Franchise 10-year contract. Roll call vote: All members voted ave. carried.

Moved by Cole, seconded by Kelly approving the 2026 Preliminary Budget submitted by Auditor Braithwaite. Braithwaite advised the council to review the budget further. Any questions or changes can be made at the Final Budget Hearing on September 8th at 6:30 p.m. prior to submitting the Final Budget to Mercer County Auditor by October 10th.

Moved by Neumiller, seconded by Cole approving Auditor Braithwaite to attend the League of Cities Annual Conference in Bismarck from September 17-19, 2025. Roll call vote: All members voted aye, carried. DuMond asked the council if the service charges which were incurred by the previous owners could be waived as the new owners wanted to start a business using that building. A brief discussion was held. Moved by Cole, seconded by Neumiller approving to remove the late fees and the service charges for the total of \$984.25. Roll

call vote: All members voted ave. carried Auditor Braithwaite informed the council that Cahoon would sign the repayment agreement on his unpaid utilities on his property located at 1028 Main Street if the late fees could be removed from his account. She also stated that Cahoon was offered the opportunity earlier this year, and she planned to certify unpaid utilities bills to the Mercer County this year again. Attorney Solem stated that even if an individual had signed a repayment agreement, the city could still certify. With that, moved by Babb, seconded by Cole approving the unpaid utilities bills to be certified to the Mercer County and rejected Cahoon's request. Roll call vote: All members voted ave. carried. At the first meeting when a representative from Summit had attended, she stated that Summit would make sure that the individuals had a ride to wherever they needed to be as this was one of the main concerns by our residents. Council discussed the situation regarding individuals being released from Summit Counseling and what could be done. Council was informed that the City couldn't enforce anything. If there are further issues, citizens are advised to contact the Sheriff's Department directly. Chapman presented the \$11k quote from Freedom Trucking to work on the sweeper. Kelly asked if this included all necessary work to be done with the sweeper. Chapman informed that there will be minor maintenance that he will have to do in the Winter time, but the quote is included all that needed to be done. Moved by Cole, seconded by Neumiller approving the quote provided by Freedom Trucking to fix the sweeper. Roll call vote: All members voted ave. carried.

Sailer updated the council that S&R Concrete had started working on the project today. Mayor Sayler asked if the city crew still had time to paint curbs yet this Summer. Chapman will get the supplies and will plan to this done while the summer helpers are still here. Mayor Sayler reminded Chapman that flushing the lines still needed to be done this Summer.

Attorney Solem updated the council on the court case taken earlier today that the defendant was successfully prosecuted.
