CITY OF STANTON MEETING MINUTES

October 13, 2025

Mayor Sayler called the city regular meeting to order at 6:30 p.m. at the City Hall with the following members present: Kelly, Babb, Neumiller and Cole. Present were Public Works Supervisor, Chapman, Public Works Maintenance, Sailer, Auditor Braithwaite, and Attorney Solem.

Moved by Kelly, seconded by Neumiller approving the minutes of September 8th, 2025 City Council regular meetings. Roll call vote: All members voted aye, carried. Moved by Neumiller, seconded by Cole approving the August 2025 Financial Reports submitted by Auditor Braithwaite. Roll call vote: All members voted aye, carried.

Moved by Neumiller, seconded by Babb approving the security pledge for the third quarter of 2025 with Union State Bank. Roll call vote: All members voted aye, carried. A discussion was held regarding the replacement of impellers at the Miller lift station in the near future and also acquiring spare pumps for each lift station with majority of the cost be covered by the FEMA fund. Moved by Babb, seconded by Neumiller approving the estimated quote \$39855.00 for the spare pumps and the impellers from Dakota Pump and Control submitted by Chapman. The quote did not include the cost to repair the old impellers to keep as spares if they could be repaired. Roll call vote: All members voted aye, carried.

Chapman informed the council that Bakken had been having sewer line or flow issue possibly due to this little "hump" where their line came into the manhole. He suggested that they could try to grind down the hump and make a slope in hope to get a better flow. He and Sailer will try this and go from there.

Moved by Neumiller, seconded by Babb approving the building permit #25-13 submitted by The River Run to replace siding on the building located on Block 8 Lot 16. Roll call vote: All members voted aye, carried.

Mayor Sayler had asked Attorney Solem to add the Winter Parking Ordinance pertaining to campers, motor homes or trailers parking on the streets. The council discussed the 48-hour parking ordinance and wanted to establish this ordinance to include the date from October 1st to April 1st. The council also discussed the adoption of public comment policy. Attorney Solem will work on this policy. Mayor Sayler also stated that it would cost roughly \$74k for the walking path from South Avenue towards the Indian Village.

Auditor Braithwaite informed the council that she will certify the special assessments including the unpaid bills with Mercer County at the end of this month.
