1. MEETING CALLED TO ORDER

Vice Chairman Tim Flakoll called the meeting to order at 3:30 PM with all members present as follows: Duane Breitling, Jim Kapitan, Tim Flakoll, and Joel Vettel in person, and Tony Grindberg via Microsoft Teams.

Mr. Breitling moved and Mr. Kapitan seconded that the minutes of the previous meeting be approved as

Mr. Kapitan moved and Mr. Breitling seconded to approve the order of the agenda. Motion carried.

5. CONSENT AGENDA APPROVED MOTION, passed

Mr. Vettel moved and Mr. Breitling seconded to approve the consent agenda as follows: On roll call

vote, the motion carried unanimously. a. Authorize closure of Cass Highway 10 in Buffalo on Saturday, July 19 from 7 AM to Sunday, July 20 at 2 AM

- b. Grant a site authorization permit to conduct games of chance under license issued by the North Dakota
- Attorney General's Office on July 17, 2025, for the North Dakota Chapters of Delta Waterfowl, Inc. at the Hartl Ag Building, Red River Valley Fairgrounds in West Fargo.

6. PUBLIC COMMENT

Mr. Flakoll asked for public comment and hearing none, moved on to the regular agenda items.

7. ORDINANCE #2007-01, Second reading of amended Cass County Highway Access held and approved County Engineer, Kyle Litchy was present and said the request today is to update the Cass County Highway Access Ordinance. He said the changes would more effectively regulate access onto county roads by defining access distances required one fourth mile spacing inside and one half mile spacing outside city limits He said the revision also includes changing the performance guarantee for temporary access facilities from \$1,000 to \$5,000.

Mr. Kapitan moved and Mr. Breitling seconded to approve the second reading of Amended Ordinance #2007-01, Cass County Highway Access and approve the revisions as published. On roll call vote, the motion carried unanimously

8. RESOLUTION #2025-07, Public hearing on host approval for the issuance of revenue bonds for Sanford approved

Ronni A. Martin of Chapman and Culter LLP on behalf of Sanford Health, was present via Microsoft Teams to discuss a request for the Commission to adopt a resolution calling for a public hearing on host approval for the issuance of revenue bonds on behalf of South Dakota Health and Educational Facilities Authority and authorize the publication of a notice of the public hearing. Ms. Martin said the Commission will then be asked to host the public hearing during their meeting on May 19, 2025. She said Cass County is not liable for the tax-exempt bonds, Cass County is asked to hold a public hearing to meet federal income tax requirements for Sanford to be in a position to issue tax-exempt bonds and use a portion of the bonds within Cass County. MOTION, passed

Mr. Breitling moved and Mr. Kapitan seconded to adopt resolution #2025-07 calling for a public hearing on host approval on the issuance of revenue bonds, series 2025 (Sanford) on behalf of Sanford by the South Dakota Health and Educational Facilities Authority and authorize the publication of a notice of the public hearing. On roll call vote, the motion carried unanimously.

City of Fargo Assessor, Mike Splonskowski was present to discuss an abatement application submitted by Petar Valkov for a property located at 85 22nd Avenue North in Fargo. He said the applicant filed the abatement stating that the condition of the house was not reflected in the current valuation. Mr. Splonskowski said the Fargo Assessing Office reviewed the property and found the property had deferred maintenance, was valued higher than similar properties, sales of similar properties were lower than the current value, and the similar sales had a double stall garage where the subject property had one single stall. He said the recommendation by the Fargo Assessing Office and approved by the Fargo City Commission is to reduce the value from \$338,000 to \$308,100 for the 2024 tax year.

Mr. Kapitan moved and Mr. Breitling seconded to approve the abatement application and reduce the value of parcel 01-2120-00250-000 from \$338,000 to \$308,100 for the 2024 tax year. On roll call vote, the motion carried unanimously.

10. FARGO PROPERTY TAX INCENTIVE, <u>TIF approved for Lennon Lofts</u> At the Commission meeting on Monday, April 7, 2025, the Commission considered approval of the Lennon

Lofts TIF Application. The Board made a motion to not participate in the request and continue negotiating with the developer as described in N.D.C.C 40-05-24 and directed Commissioner Kapitan and County Administrator to continue the discussion with the developer. Mr. Wilson said he worked with Commissioner Kapitan and Commissioner Grindberg and proposed the County participate in the TIF with a 100% exemption for years 1-5 for the Renaissance Exemption, and at 50% for years 6 to 10. Mr. Grindberg said he appreciates the effort to find a solution that works for the County and developer. He said he would like the County to meet internally to discuss the best steps forward and what latitude the County has to approve incentives and define a new normal with upcoming tax caps and budget constraints. Mr. Flakoll said he had the Finance Office run a report to see how much funds the County is not bringing in due to incentives and the cost is about \$1.25 million.

Mr. Kapitan moved and Mr. Vettel seconded to participate in the request for Tax Increment Financing (TIF) assistance in the City of Fargo submitted by Lennon Lofts for a 22-unit apartment building at 220 6th Avenue North with a 100% exemption for years 1-5 for the Renaissance Exemption, and at 50% for years 6 to 10. On roll call vote, the motion carried with Commissioner Vettel, Breitling, and Kapitan voting "yes" and Commissioners Grindberg and Flakoll voting "no".

11. FINANCE OFFICE, 2026 budget session information and budget calendar approved

Brandy Madrigga, County Finance Director was present and discussed the 2026 budget session and budget calendar. She said due to the budget caps concerning the total amount of property tax levied by taxing districts anticipated to be implemented by the North Dakota Legislature, the Finance Office is recommending County Departments target a 0% increase in budgets excluding staffing costs, new full time employee freeze, cost containment and efficiencies, provide justifications for budget increases, and conduct a final review meeting with the department head, portfolio commissioner, and representatives from the Finance and Administration Offices. Ms. Madrigga discussed overall County strategies including maintaining a fund balance of 30% to 40% to maintain the County's Moody Credit Rating of Aa3 and maintaining the building fund. Mr. Grindberg said it is important for the County to be fiscally conservative for the next few years and it is

incumbent upon the Commission to take care of staff and ensure fiscal strength for the future. MOTION, passed Mr. Grindberg moved and Mr. Breitling seconded to approve the budget calendar and directives as

presented by the Cass County Finance Office, for the preparation and approval of the 2026 Cass County Budget. On roll call vote, the motion carried unanimously.

12. VOUCHERS, Approved

Mr. Vettel moved and Mr. Breitling seconded to approve Voucher No. 349510 through Voucher No. 349801 for a total of \$607,758.20. On roll call vote, the motion carried unanimously.
