Minutes published prior to Governing Body's Review & Revision OFFICIAL PROCEEDINGS OF THE HETTINGER CITY COUNCIL HETTINGER. NORTH DAKOTA **OCTOBER 8, 2025** 

The Hettinger City Council met in regular session at the Hettinger Armory Conference Room with the following present: Randy Burwick. Michele Gaylord, Carl Ebert and David

Council President Ebert called the meeting to order at 7:00

SEPTEMBER 10, 2025 MI-NUTES Council Member Parrill moved to approve the minutes of the regular scheduled meeting, Second by Council Member Gavlord, and by unanimous vote, motion carried.

SEPTEMBER 24, 2025 MI-**NUTES Council Member Parrill** moved to approve the minutes of the special meeting, Second by Council Member Burwick. and by unanimous vote; motion carried.

AGENDA: Council Member Burwick moved to approve the agenda as presented, Second by Council Member Parrill and by unanimous vote, motion car-

FINANCIAL STATEMENT: Was Reviewed, Council Member Parrill moved to approve the financials, second by Council Member Gaylord, and by unanimous vote, motion carried.

CORRESPONDENCE: The lease agreement for the Graphic Attic building on South Main Street was extended until 12/31/2025, the Council was happy with the draft that is now ready for signing. A letter from the County Auditor was reviewed on a house located in Hettinger that will be at the 2025 Foreclosure auction this November. The Jaycees submitted a quarterly report of where they have donated their funds.

Mayor Lindquist joined the meeting

MAYOR/COUNCIL RE-PORTING: Mayor Lindquist discussed meetings he had with Council Member Gaylord on zoning and ordinance changes to present later this meeting. Council Member Parrill discussed conversations he had with Road Superintendent Blade on a couple street issues as well as a couple signs that are down in the city. Council Member Gaylord discussed the Multi Mitigation Plan has been approved and available for viewing.

SALES TAX REPORT: Was reviewed

ROAD SUPERINTENDENT-JUSTIN BLADE: met with the Council briefly to discuss a few signs will be re-set as they have been run over by semis. Discussion was had on the closure of the branch and grass site at the end of this month, along with the Adams County landfill. Mr. Blade discussed his planning efforts for the upcoming snow/ ice season, he is hoping to have the ability to purchase sand/salt from the State.

ARMORY MAINTENANCE CUSTODIAN: Fitness Center membership money brought in last month was \$1,535.00. Fitness Center updates were discussed. One member applied for Fun Run and Walk money on behalf of the city and has been awarded \$1k for some of the updates. Ms. Schalesky questioned spraving all the weeds and weed grass to the South grounds of the Armory. Drolc Electric changed out the furnace filters; other maintenance needs were discussed. Council Member Gaylord distributed a draft updated contract for the custodial duties. Ms. Schalesky

discussed her concerns, as well as her request for a 3% increase in pay. Discussion was had about the increase in pay and the concerns within the contract. Changes will be completed and ready for an updated contract to take into effect January 1, 2026.

USDA COMPLIANCE: CC Flooring was not interested in the men's shower room, so the Council will need to be in contact with another contractor.

GAMING SITE AUTHORIZA-TION: a special meeting was held this month for two gaming site authorizations from Horse Race ND to locate gaming in Suzie's LLC (S Main Street) and Good Hope LLC (Adams Ave). The Council denied the two requests for the reasons to try and get the gaming funds to stay local and have the two entities request gaming from the Jaycees. Pete Bushey, with Horse Race ND requested the Council revisit the gaming site authorizations. Allan Slater was at the meeting and requested any information. Mr. Slater questioned the reasoning of why the authorizations were denied. The Council discussed why the vendors were being changed, Mr. Slater with Good Hope, discussed the original gaming entities chosen had a background he was not comfortable with. Mr. Slater discussed his non-profit being the local entity and wanted a re-consideration. The Council questioned possibly using the Jaycees as a vendor. Mr. Slater was unsure, as when he contacted the Jaycees last year and was never contacted back. Mr. Slater was hoping to have an approved permit by the upcoming hunting season but was willing to wait and have a meeting with the entity at the next Council meeting. Mayor Lindquist discussed tabling the decision for next meeting. Council Member Burwick moved to approve the gaming site authorization from Horse Race ND for the location of Good Hope LLC, second by Council Member Ebert, and by unanimous vote; motion carried. Mr. Slater will try and get the entity to come to the next meeting to have a formal introduction.

BEER GARDEN PERMIT-PA-STIME (3) Council Member Parrill moved to approve the three beer garden permits for events at the Granary building and Hettinger armory, second by Council Member Burwick, and by unanimous vote; motion carried.

**GAMING PERMIT REQUEST:** Cedar Creek Pheasants Forever application for a raffle was reviewed. Council Member Ebert moved to approve the raffle permit, second by Council Member Parrill, and by unanimous vote: motion carried.

PERMIT GAMING QUEST: West River Ducks Unlimited application for a raffle was reviewed. Council Member Ebert moved to approve the raffle permit, second by Council Member Parrill, and by unanimous vote; motion carried.

GAMING PERMIT RE-QUEST: the Nighthawk Pin Club application for a raffle was reviewed Council Member Fbert moved to approve the raffle permit, second by Council Member Parrill, and by unanimous vote; motion carried

GAMING PERMIT QUEST: the Hettinger Close Up application for a raffle was reviewed. Council Member Ebert moved to approve the raffle permit, second by Council Member Parrill, and by unanimous vote; motion carried

SHERIFF FISHER: met with the Council to provide updates from his department. The feral cat situation will be looked into the next month. A location was found by Mayor Lindquist and will be a resource for the Sheriff's

Department as a safe location for placement of the feral cats. Sheriff Fisher shared his gratitude of the community during the tragic event of Deputy Cude's family. Discussion was had on de-briefing sessions and programs that have happened and planned to be implemented for our community and school to help with depression and mental issues. The Council thanked Sheriff Fisher for his efforts. HETTINGER CHAMBER-AC-

DC DIRECTOR: Rebecca Ferderer met with the Council to discuss updates from her offices. Ms. Ferderer requested to close South Main Street from Pastime South to the end, leaving the end intersection open for the Trunk or Treat event. Also planned to have the Armory reserved for a back up location. The Community Promotions Office building roof needed maintenance, as Ms. Ferderer and her assistant had to shovel debris off the roof. Ms. Ferderer discussed possibly eliminating meetings at the boardroom and urging them to rent the Rural Collective. Discussion was had on the firework funding disbursements, she worried if the Attorney General's office would question, as they are not an actual municipality. Mayor Lindquist questioned if the city would be a good idea taking in gaming funds. The Ladies Night Out event is happening tonight, so Ms. Ferderer invited everyone out tonight. The Bowling Alley flooring and other needs within the building were discussed, ACDC formed a committee to work out details. Ms. Ferderer and ACDC is working with Dr. Mark Nelson to try and get dentistry work back into Hettinger. Council Member Parrill moved to approve closing South Main Street Friday October 31st for Trunk or Treat, second by Council Member Burwick, and by unanimous vote; motion carried.

COMMENT **PUBLIC** SECTION: Allan Slater requested information on power lines and code for electrical lines coming into the meeting, the Council directed Mr. Slater to contact MDU.

**ENGINEERING:** BROS7 Shannon Hewson met with the Council and shared updates. The contractor will be completed with their clean up and imagery of the sewer system. Mr. Hewson will present any findings at the next meeting. ZONING AMENDMENT AND

RATE DISCUSSION: Katie Roseland was at the meeting for the discussion and presentation. A rate schedule was reviewed. Council Member Parrill moved to approve and adopt the rate schedule, second by Council Member Burwick Discussion was had on possible inclusions such as demolition permitting. The motion died, due to no vote. Council Member Parrill moved to approve and adopt the rate schedule, minus the demolition permit, second by Council Member Burwick, and by unanimous land discussed two violations, a camper hooked up to city sewer and a storage container unit located in a yard, Ms. Roseland has followed up on the violations. Amendment 25-03 (tree ordinance) for maintenance needs of existing tree locations for public safety, this will be added to the next meeting agenda. Ms. Roseland discussed changes for the zoning ordinances to present that she worked with Council Members Gaylord and Lindquist. Changes included removal of the building inspector requirements including the wordage on Certificate of occupancy. Several other changes and clarifications were discussed to be on the agenda for the first reading at the next meeting. A few changes were discussed and will be changed for next month's first reading. Discussion was had on trying to work on sections for any changes every year, to keep up to date. Aaron Roseland was in attendance and shared his concern on the cost of fines, as the costs have not been increased/ adjusted in years, and hoped the Council would take them into consideration when going through the zoning and ordinances. Mr. Roseland also discussed the need to follow through with compliance with the zoning and ordinances. Mr. Roseland updated the Council of the court case with Suzie's LLC on the AC unit. The Court found Mr. Slater guilty of the infraction but changed the penalty from the original \$500 with \$400 suspended, to a \$25 fine. The Council will work on the remaining ordinances in the next couple months.
