Facility Description
The reapplication is for two waste stabilization ponds which service the City of Reeder. The discharge facility is located in the NW1/4, Section 9, Township 130N, Range 98W. Any discharge would be to an unnamed tributary of Buffalo Creek, a Class III stream.

Tentative Determinations
Proposed effluent limitations and other permit conditions have been made by the Department. They assure that State Water Quality Standards and applicable provisions of the FWPCA are protected.

All comments received by December 12, 2025 will be considered prior to finalizing the permit. If there is significant interest, a public hearing will be scheduled. Otherwise, the Department will issue the final permit within sixty (60) days of this notice.

NDSU Extension to host Getting It Right crop production webinars

Topics will include agronomic best practices, pest and disease management, market forecasts and more.

Farmers and crop advisers looking for up-to-date, research-based crop production recommendations are encouraged to participate in NDSU Extension's Getting It Right crop production webinar series.

The series is sponsored by the North Dakota Soybean Council, Northharvest Bean Growers Association, National Sunflower Association, North Dakota Corn Utilization Council and Northern Canola Growers Association.
