Devitt should have filed the lawsuit against the political subdivision of Grant County rather than the commissioners as individuals. The judge also stated a 30-day time limit from the day of the commissioners' decision had passed.

Devitt's default judgment request was based on the appointment of Schmidt as special assistant state's attorney Feb. 4 to handle the case, claiming technicalities with an oath of office should void Schmidt's representation.

Reich said the issue of the oath was corrected March 4, stating he would not grant a default judgment on that basis.

In his motion to dismiss, Schmidt argued Devitt sued the wrong parties and Devitt's challenge of the commission's decision was not completed within the 30-day window. He also argued Devitt did not have a private right of action, meaning he did not have the authority to file a civil lawsuit.

Schmidt also argued Dillon's appointment is valid unless overturned by a court.

"Even if Mr. Devitt was correct ... the sheriff has been a resident of Grant County now for the

required amount of time. ... We can't go back and undo all of this stuff. It's already happened," Schmidt said.

"The only relief that I've ever requested from the board of commissioners was that they nullify his Aug. 21 appointment, ensure that he's a resident of Grant County and then reappoint him," Devitt said.

In January, Devitt circulated a petition requesting the governor to remove the Grant County sheriff and two county commissioners from office.

Devitt was gathering signatures to remove Dillon from office due to what Devitt believed was a violation of residency requirements. Devitt was asking for removal of commissioners Zenker and Meyer for failure to uphold their oath of office, he said.

The petition required 50 signatures, and a sponsoring five-person committee, and Devitt had 90 days to gather the signatures. While he stated he had 43 signatures in January, he recently told the newspaper he did not obtain the required 50 signatures.

Following the resignation of the former sheriff, Garrett Harding, the county commission appointed

Dillon as sheriff on Aug. 21, 2024, to fill the remainder of Harding's term, ending in 2026. On Dec. 18, 2024, the commissioners reaffirmed Dillon's appointment after Devitt had brought his concerns to the commission.

Dillon stated he moved into the county-owned house in Carson on Aug. 14, 2024, maintaining he is meeting residency requirements.

Devitt contends Dillon is not meeting residency requirements by keeping a home in Hettinger County.

Following the Dec. 18, 2024, commission meeting, Devitt contacted the N.D. secretary of state to confirm if Dillon had voted in the proper county.

Dillon voted in Hettinger County during the November 2024 general election, according to a letter from the secretary of state to Devitt dated Jan. 7.

Devitt claims a vacancy still exists in the sheriff's role, because Dillon vacated his position by voting in Hettinger County.

The commissioners' decision is valid unless it is overturned by court, Schmidt countered.

Daniel Devitt asked if an emailed statement had been distributed to the Board. Chairman Zenker stated that he was reading it. Commissioner Meyer stated that due to pending litigation, nothing could be discussed during the regular meeting. Mr. Devitt left the table.

Jared Fischer, Emergency Manager/911 Coordinator said he is trying to set up a Community Emergency Response Training. He also talked about the SIRM program and radio options for the road department.

Sheriff Dillon informed the Board that Deputy Dahl tendered his resignation effective March 31, 2025.
