Amendment of
Chapters 3 and 4
Enderlin Revised
Ordinances

WE, THE CITY COUNCIL OF THE CITY OF ENDERLIN, NORTHDAKOTA, do hereby amend Chapters 3 and 4, by changing section 3.0207 and section 4.0304 to read as follows: 3.0207 Burning

It shall be unlawful for any person, firm or corporation to burn anything upon any of the public-streets, sidewalks, alleys or public way in the City. Unless otherwise stated, it shall be unlawful for any person, firm or corporation to burn any lawn clippings, grass, leaves, wood, branches,sticks, rubbish, refuse, garbage, or hazardous chemical substances upon any outdoor privateproperty within the City. A person may apply for a permit that the City may grant or refuse in itssole discretion for permission to burn lawn clippings, grass, leaves, wood, branches, sticks, butnot rubbish, refuse, garbage, nor hazardous chemical substances. The City Auditor shall have discretion to grant or deny any such permit in accordance with direction from the City Councilfrom time to time and any denial of such permit may be appealed to the City Council whosedecision shall be binding. A person who uses an outdoor fire-place and/or fire containmentsystem (such as for example, a portable fireplace) may, without a permit, burn in such fireplaceor containment system branches, sticks, or wood if a burn ban is not in effect by order of the city,county, or state for the area comprised of the City of Enderlin. 4.0304 Open Burning Prohibited

Unless otherwise stated, it shall be unlawful for any person, firm or corporation to burn any lawnclippings, grass, leaves, rubbish, refuse, garbage, or hazardous chemical substances upon anyout-door private property within the City. A person may apply for a permit that the City maygrant or refuse in its sole discretion for permission to burn lawn clippings, grass, leaves, wood,branches, sticks, but not rubbish, refuse, garbage, nor hazardous chemical substances. The CityAuditor shall have discretion to grant or deny any such permit in accordance with direction fromthe City Council from time to time and any denial of such permit may be appealed to the CityCouncil whose decision shall be binding. A person who uses an outdoor fireplace and/or firecontainment system (such as for example, a portable fireplace) may, without a permit, burn insuch fireplace or containment system branches, sticks, or wood if a burn ban is not in effect byorder of the city, county, or state for the area comprised of the City of Enderlin.
