JAMESTOWN — The North Dakota Department of Transportation (NDDOT), in cooperation with TI-Zack Concrete Inc., will begin Phase 2 of the highway improvement project on U.S. 52/281 from 37th Street Southeast to 17th Street Southwest in Jamestown on Monday, July 14. Completion is expected by

permitting.

During this phase, construction will take place in the outside lanes and right-turn lanes of U.S. 52/281. The work includes concrete pavement repair and ADA-compliant pedestrian ramp upgrades.

The outside and rightturn lanes will be closed during construction. Additionally, there will starting on Tuesday, July 15, for concrete pavement repair work on the Interstate 94 westbound onramp and eastbound offramp at Exit 258.

Traffic Impacts and Detours

· I-94 eastbound motorists should use Exit 260 to turn around and access U.S. 52/281 via Exit 258 during the ramp closure. • U.S. 52/281 northbound

wanting to travel westbound on I-94 will need to use eastbound I-94 to Exit 260, turn around and head west.

Traffic control devices, signs and flaggers will be used to guide motorists through the work zones. Drivers are encouraged to slow down, use caution and follow detour

signage.
