#### Rams expect WR Puka Nacua to play vs. 49ers

Los Angeles Rams wide receiver Puka Nacua is expected to play Sunday against the San Francisco 49ers despite a rib injury, Rams coach Sean McVay said on Wednesday.

Nacua, 24, will be limited at practice on Wednesday, but after his rib imaging came back clean, he should play on Sunday, the coach said. The 49ers (6-3) host the Rams (6-2) in a tight race in the NFC West.

McVay had said after the 34-10 home win over the New Orleans Saints on Sunday that Nacua's injury wasn't serious. Nacua was injured in the third quarter on a 3-yard rushing play in which he was tackled by Saints linebacker Demario Davis with under six minutes remaining. He went to the locker room to be examined and was initially listed as questionable to return with a chest injury. He returned to the field early in the fourth quarter.

Nacua had seven receptions for 95 yards and one touchdown before exiting.

Nacua missed Los Angeles' previous game against Jacksonville on Oct. 19 due to an ankle injury. The Rams had a bye last week.

#### Texans QB C.J. Stroud ruled out vs. Jaguars

The Houston Texans ruled out quarterback C.J. Stroud for Week 10 with a concussion, pushing backup Davis Mills into the starting role for Sunday's home game against division rival Jacksonville.

Stroud was injured early in the second

quarter of an 18-15 home loss to the Denver Broncos. He was scrambling downfield and went into a late slide before Denver cornerback Kris Abrams-Draine delivered a blow to Stroud's midsection.

Mills, 27, replaced Stroud and completed 17 of 30 passes for 137 yards last week.

Mills made 26 starts over his first two seasons (2021-22) with the Texans and compiled a 5-19-1 record. All of his starts came before Stroud was the No. 2 choice in the 2023 NFL Draft. Case Keenum was the starter when Stroud was out two games due to a concussion as a rookie.

#### Cardinals QB Kyler Murray (foot) lands on IR

Out since Oct. 5 with a foot injury, Arizona Cardinals quarterback Kyler Murray was placed on injured reserve Wednesday, and will miss at least four more games.

The Cardinals announced Tuesday that Jacoby Brissett would start against the Seattle Seahawks, but the IR move clears the way for Brissett to remain the starter for the foreseeable future.

ESPN reported earlier this week that the Cardinals have been informed by foot doctors that the two-time Pro Bowl QB's recovery timeline could last four to eight weeks.

With the IR move, the earliest Murray could return is Dec. 7 for a Week 14 home matchup against the Los Angeles Rams.

Murray, 28, has completed 68.3% of his passes for 962 yards with six touchdowns and three interceptions in five starts this season. The

No. 1 overall selection of the 2019 NFL Draft has rushed for a team-high 173 yards and one score.

Brissett, 32, has passed for 860 yards and six touchdowns in his three starts. He also has been intercepted just once. He passed for 261 yards and two touchdowns against Dallas in Monday's 27-17 victory.

In Murray's five starts, Arizona averaged 20.6 points and scored more than 21 points just once.

#### Jazz C Walker Kessler out for season

Utah Jazz center Walker Kessler will miss the rest of the season due to a torn labrum in his left shoulder and will have surgery, the team announced on Wednesday afternoon.

The procedure is scheduled for Thursday in Los Angeles and will be performed by Dr. Neal ElAttrache, the Jazz said.

Kessler, 24, has not played since a 118-96 loss at Phoenix on Friday. He has averaged career highs of 14.4 points, 3.0 assists, 1.4 steals and 30.8 minutes along with team highs of 10.8 rebounds and 1.8 blocks in five games (all starts).

Memphis selected Kessler with the 22nd overall pick of the 2022 NBA Draft out of Auburn. The Grizzlies traded him the next day to the Minnesota Timberwolves, who dealt him on July 6, 2022, to the Jazz as part of a package of players and picks for Rudy Gobert.

For his career, Kessler averages 9.5 points, 9.3 rebounds, 1.2 assists, 2.4 blocks, 0.5 steals and 25.3 minutes in 201 games (125 starts).

## Seniors must pick replacement for discontinued Medicare Advantage plans

FARGO — This year's open enrollment period for seniors covered by Medicare Advantage plans is causing turmoil for those whose plans are being discontinued — and failure to choose a replacement plan can result in a loss of coverage.

Faced with skyrocketing claims costs, many health insurers are eliminating some of their Medicare Advantage plans. Those affected must select a new health insurance plan during the annual open enrollment period, which started Oct. 15 and ends Dec. 7.

Those covered by Medicare supplement plans, commonly called Medigap, are not affected by the Medicare Advantage plan changes.

With about 147,000 North Dakota residents on Medicare, the widespread reshuffling of Medicare Advantage plans will affect many seniors, and Michelle Kommer, president of the HighRoad Partners insurance agency in Fargo, is

sounding the alarm.

"This is an especially chaotic year in the already-complicated world of Medicare, and I'm fearful that some of the changes will be missed by our seniors and will have a catastrophic impact," she said.

Kommer worries some seniors might fail to act in time. If they have a plan that is terminating, they have to enroll in a new one, or they won't have coverage in 2026, she explained.

To make matters worse, because of the high costs, many insurers are not mailing out plan coverage details — so seniors without the ability to go online will be unable to do comparison shopping, Kommer said.

Insurers are required to notify their customers at least three times, but Kommer said seniors get so many mail solicitations this time of year, some might miss the notification letters.

"At this time of year, seniors are bombarded with commercials, mail, robocalls, etc., and based on our experience, do not see the notices that their carriers are required to provide regarding their plan changes," she said.

Also, because of spiraling costs, some health insurers are no longer paying insurance brokers, leaving consumers without an independent source of information.

The discontinuation of some Medicare Advantage plans is driven by spikes in claims that are greatly exceeding premiums, so they are no longer sustainable.

"The Medicare Advantage plans of most carriers are, in my words, underwater," Kommer said.
