The Velva Public School Board met in the meeting room at 5pm on Monday December 8, 2025. President Selzler called the meeting to order at 5:00pm. Board members Selzler, Haskins, Harden, Kasowski were in attendance. Also present were Monty Mayer, Kelly Mogen, Skyler Helseth, John Ulland, Tracy Ulland, Julie Froshaug, Gavin Schmaltz, Coach Wiedler, Coach Nagel, Luke Selzler, Mason Kraft, Cooper Kittelson, Matt Bryant, Reese Steffen, Isabelle Slater, Mrs. Froshaug, Emily Ulland, Gavin Schmaltz, Jamie Gjellstad, and Odin Gjellstad. The Pledge of Allegiance was recited by all.

There was a motion to approve the agenda with the addition of having discussion on the Activity fund outstanding checks document by Haskins with a 2nd from Harden. Motion carried.
