Amendment of Chapter 5 Ellendale Revised Ordinances Amendment of 5.0304

WE, THE CITY COUNCIL OF THE CITY OF ELLENDALE, NORTH DAKOTA, do hereby amend Section 5.0304 of Chapter 5 of the Ellendale Ordinances to read as follows:

5.0304 District "R-1" Boundaries The boundaries of the "R-1" Residential District are described as follows:

All areas not listed within Districts "C-1", "C-2", "R-2", "M-1", "M-2" and "I-1" that are within the City limits shown on the official zoning map on file in the office of the City Auditor shall be a residential district. R-1 shall also include a portion of land annexed into the City of Ellendale, which portion is platted as "Hasz Family Subdivision."

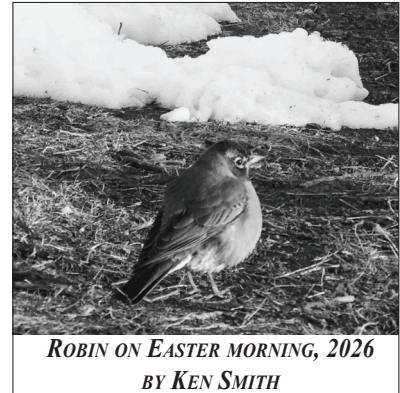
