

DICKEY COUNTY COMMISSIONERS MEETING AUGUST 18, 2026

Commissioner Meeting August 18, 2026

Chair Kacey Holm called the meeting to order at 9:00 am. Commissioners Jerry Walsh and Brandon Carlson, Kacey Holm, and John Hokan Marke Roberts were also present. Applied Digital representative Emma Perrotti, State's Attorney Kim Radermacher, and County Auditor Wanda Sheppard were also present. Pledge of Allegiance was recited.

Additions to the Agenda

Flock cameras

Assessor cost for City of Ellendale

Hokana moved to approve the amended minutes from the July 16th budget meeting and the August 4th Commission meeting. Roberts seconded. Motion carried.

Sheriff Chris Estes and Clerk of Court Andi Schimke joined the meeting at 9:14.

Walsh moved to approve the vouchers as presented. Carlson seconded. Roll call was Walsh yes; Hokana yes; Carlson yes; Holm no; Roberts yes. Motion carried.

Carlson made a motion to approve the July 2026 financials. Walsh seconded. Roll Call was unanimous. Motion carried.

Schimke discussed changes to the mailing requirements of passport paperwork, requiring the purchase of a special printer. Walsh moved to approve the printer purchase. Carlson seconded. Roll call was unanimous. Motion carried.

A quote for grinding the tree stumps in the Courthouse yard was reviewed. Sheppard stated this was not included

in the 2027 budget as the quote was received too late. Walsh will check if the county could use the grinder the city has.

The difference in the cost of the assessor between Oakes and Ellendale was discussed. Tax Director Flaherty

joined the meeting. Roberts stated Oakes pays \$12,000 for their own assessor, while Ellendale is charged by the county \$3,500 in 2025 last year. Flaherty stated the county charges the city based on the number of houses. Discussion followed about the fairness of the fees. Oakes can contract with the county at the county rate.

Estes spoke with the Commission concerning the Flock cameras that would be installed on Highway 281. Estes stated there needs to be a policy in place for their use. The camera is locking at the type of vehicle, not the person that is in the vehicle. Estes stated that a person can't be prosecuted off the camera. The policy will be presented at the time of activation. Someone from another area cannot use our cameras without our permission. A decision was made not to activate at this time. Commission asked Radermacher to review the policy as well.

The meeting went into recess from 10:30-145.

Walsh moved to approve the ballot measure wording to increase the mills collected for senior citizen services from 1 mill to two mills, which was requested by the Senior Citizen Board. Carlson seconded. Roll call was unanimous. Motion carried.

Hokana moved to put a ballot measure to increase the mills for extension from two mills to 4 mills. And approve the wording of the measure. - Carlson seconded. Roll call: Hokana yes; Walsh yes; Roberts yes; Carlson no; Holm yes; Motion carried.

Hokana moved to accept the 2027 preliminary budget. Holm seconded. Roll call: Holm yes; Hokana yes; Walsh yes; Roberts no; Carlson no; Motion carried.

Walsh moved to sign the Task Order with KLJ Engineering for the County Road 2 project shared with Lamoure County. Carlson seconded. Roll call was

unanimous - Roberts moved to sign Amendment #3 to the professional services contract with KLJ, extending the contract to May 2028. Carlson seconded. Roll call was unanimous.

A Permit for Dickey Rural Network to bore under the road to install fiber optic cable along 95th Street. Carlson moved to approve the application; Walsh seconded. Motion carried.

Hokana made a motion to Adjourn at 11:50.
