

More insurance statements coming to North Dakota Newspapers

NORTH DAKOTA NEWSPAPER ASSOCIATION PRESS RELEASE

North Dakota newspaper readers will notice more insurance company financial statements in their papers this year due to a recent change in state law. During the 69th Legislative Assembly, lawmakers passed House Bill 1398, which updated how often and where insurance companies must publish their annual financial abstracts. The change nearly doubles the number

of insurance companies required to publish these notices and requires them to appear in newspapers across all eight judicial districts in the state. Insurance abstract statements have appeared in North Dakota newspapers for decades, but the new law will make them much more visible. Last year, the notices were published only in the largest newspapers within each judicial district. Before that, the workload was shared more evenly among newspapers statewide. Traditionally, these notices are published in May. However, so far only

about half of the insurance companies have submitted their information. "This will require the notices to be published in batches, which could stretch into July," said Cecile Wehrman, executive director of the North Dakota Newspaper Association. The law requires insurance companies to publish their abstract statements at least three times in newspapers of general circulation that are distributed evenly throughout the state. Proof of publication must then be filed with the insurance commis-

sioner. "These changes were made to restore publication opportunities to newspapers across the entire state, instead of concentrating them in only the largest papers," Wehrman said. The cost of publishing the notices is paid by the insurance companies themselves. No tax dollars are used. The purpose of the insurance abstract statements is to give consumers information about the financial stability of the insurance companies they rely on for property, casualty, life, and health insurance.
