

NORTH DAKOTA DEPARTMENT OF ENVIRONMENTAL QUALITY PUBLIC NOTICE OF OPPORTUNITY TO COMMENT ON DRAFT PERMIT FOR A SOLID WASTE MANAGEMENT FACILITY UNDER THE NORTH DAKOTA SOLID WASTE MANAGEMENT RULES

BACKGROUND:

The North Dakota Department of Environmental Quality (Department) received a permit application from Minnkota Power Cooperative, Inc. for the renewal of an existing special waste surface impoundment and landfill facility permit. Additional information was submitted for a minor modification to the closure plan for the facility.

Minnkota Power Cooperative, Inc. – Milton R. Young Station (Minnkota Power) currently owns and operates a surface impoundment to be closed with special waste in place, regulated under solid waste management facility Permit 0159 on approximately 211 acres located about five miles southeast of the City of Center in Sections 5 and 8 within Township 141 North, Range 83 West in Oliver County, ND. Minnkota Power is proposing to renew its permit. The facility was first permitted in 1995 and began accepting waste in 1997.

The Department believes that a permit which meets the requirements of the North Dakota Solid Waste Management Rules and is protective of human health and the environment

can be issued to Minnkota Power Cooperative, Inc. and has prepared a Draft Permit for public review and comment.

PUBLIC COMMENTS AND HEARING

As required by Section 33.1-20-03.1-03 of the North Dakota Administrative Code, the Draft Permit will be available for public review and comment for thirty (30) days following publication of the Public Notice. The public comment period begins September 24, 2026 and ends October 23, 2026. During that period, any interested person may submit written comments and request a public hearing by stating the nature of the specific issues to be raised. A fifteen (15) day notice will be provided before any hearing is scheduled. The North Dakota Department of Environmental Quality will consider all comments prior to taking any action on the permit.
