Major components of the Work include: Tree and shrub procurement, delivery to project site, site preparation and utility locating, installation of plantings and general landscape mulching of planting areas. There are three separate state parks, each park having its own individual bid: Fort Abraham Lincoln State Park with 53 trees and 47 shrubs, Morton County; Fort Ransom State Park with 55 trees and 10 shrubs, Ransom County; and Fort Stevenson State Park with 83 trees and 10 shrubs, McLean County.
