

# OLIVER COUNTY MEETING MINUTES

May 18th, 2026  
 OLIVER COUNTY COMMISSION PROCEEDINGS were called to order at 9:02 am with all members present.  
 Alice Grinsteinmer, Oliver/Mercer Emergency

Manager, presented an Internal Emergency Declaration to the Commission and recommended adoption. Lee Husfloen moved and Bradley Dahl seconded the motion to adopt the below Internal Emergency Declaration.

A roll call vote was held; Lee Husfloen-Aye, Bradley Dahl-Aye, Rob Schmidt-Aye. The Internal Emergency Declaration passed.

Patrick Waters, States Attorney, discussed an email regarding public hearings and meetings being held at the Courthouse due to safety concerns.  
 Bradley Dahl moved and Lee Husfloen seconded the motion to hold all future county meetings at the Courthouse Courtroom with any speakers being held in the meeting room and escorted into the public meeting by law enforcement during the public comment portion of the meetings and then back out for the next speaker. A roll call vote was held; Lee Husfloen-aye, Bradley Dahl-aye, Rob Schmidt-aye. The motion passed.  
 Discussion was held on a proposed Joint Powers Agreement with Mercer County for the County Recorder position.  
 Lee Husfloen moved and Bradley Dahl seconded the motion to move into executive session for a reasonably predictable lawsuit.

All in favor, none opposed; motion carried.  
 The Commission meeting went into executive session at 9:31 am.  
 The Commission meeting was called back into regular session at 9:56 am.  
 Bradley Dahl moved and Lee Husfloen seconded the motion to have the States Attorney move forward to open an investigation into alleged allegations of a county employee.  
 A roll call vote was held; Lee Husfloen-aye, Bradley Dahl-aye, Rob Schmidt-aye. The motion carried.  
 The meeting was adjourned at 9:57 am.

**INTERNAL EMERGENCY DECLARATION**  
 Oliver County  
 May 18, 2026

WHEREAS, all elected officials, appointed officials, employees, and members of boards and commissions are directed to immediately report any threats, intimidating conduct, or security concerns to the County Sheriff's Office and County Administration. Documentation should include date, time, location, individuals involved, and any witnesses, where applicable.

WHEREAS, this Internal Emergency Declaration shall remain in effect immediately upon issuance and will continue until it is determined by the County Commission, in consultation with law enforcement and emergency management officials, that the credible threat level has sufficiently diminished and normal operations may safely resume.

NOW, THEREFORE, BE IT RESOLVED, that pursuant to the authority granted under North Dakota Century Code § 37-17.1-10, the Oliver County Commission hereby declares a local emergency as Oliver County remains committed to transparent governance, public participation, and the safety of all individuals involved in County operations. This declaration is a precautionary measure intended solely to protect life safety and ensure the continuity of essential governmental services during a period of elevated concern.

BE IT FURTHER RESOLVED, that this declaration shall:

1. Take immediate effect upon approval and issuance by the Oliver County Commission
2. Remain in effect until formally terminated by action of the County Commission in consultation with law enforcement and emergency management officials
3. Authorize the implementation of reasonable and necessary security measures to protect County officials, appointed officials, employees, and board members
4. Permit modification of public meeting formats, locations, access protocols, or security procedures as deemed necessary to ensure safety and continuity of government
5. Direct all County departments, offices, and personnel to fully cooperate with law enforcement and emergency management directives related to this declaration
6. Require that all threats, harassment, or safety concerns be documented and immediately reported to appropriate law enforcement authorities
7. Ensure that all actions taken under this declaration remain consistent with applicable state law and constitutional protections

WHEREAS, this Internal Emergency Declaration is hereby issued by Oliver County due to credible reports and recent incidents indicating threats of death, bodily harm, intimidation, and harassment directed toward County elected officials, appointed officials, County employees, including County Commissioners, members of the Planning and Zoning Board, and all other individuals engaged in official County government duties.

WHEREAS, these threats have emerged in connection with ongoing public tension and civil unrest surrounding proposed data center development discussions within the County. While public participation and civic engagement remain valued and protected, the County has a responsibility to ensure the safety, security, and well-being of all individuals performing official governmental functions.

WHEREAS, Effective immediately, Oliver County declares an internal state of emergency for security purposes only, limited to the protection of County officials, appointed officials, employees, and the continuity of government operations.

This declaration is enacted to:

- Acknowledge the presence of credible and escalating threats of violence toward County personnel
- Enable enhanced protective measures for elected officials, appointed officials, employees, Planning and Zoning Board members, and other County representatives
- Support coordination with law enforcement and security partners to mitigate risk
- Ensure continuity of essential governmental functions during the period of heightened concern

WHEREAS, during the period this declaration is in effect, the County authorizes the following measures as deemed necessary and appropriate by the County Commission Chair, Sheriff's Office, or designated emergency management personnel:

- Increased law enforcement presence at public meetings and County facilities
- Controlled or limited access to certain government buildings when warranted
- Security screening or monitoring at public meetings or hearings
- Adjustment of meeting formats, including the use of virtual participation when appropriate
