DEFAULT-Failure to fulfill an obligation to make payments when due to a lender. ENCUMBRANCE-A right attached to the property of another that may lessen its value, such as a lien, mortgage or easement. FORECLOSURE-The legal process of term inating an owners interest in property, usually as the result of a default under a mortgage. Foreclosure may be accomplished by order of a court or by the statutory process known as foreclosure by advertisement, also known as a power of sale foreclosure. LIEN-A legal claim asserted against the property of another, usually as security for a debt or obligation.
