This hearing is being held after Drain No. 4 has been in existence

for at least one (1) year and upon resolution of the District, for the purpose of determining the benefits of the drain to each tract of land within the assessed district and reassessing such benefits as may be appropriate.

At the hearing, the Board will receive and consider evidence and testimony regarding the extent of benefits accruing to each tract of land affected by Drain No. 4. The provisions of law governing the original determination of benefits and assessment of costs shall apply to any reassessment conducted.

Any landowner, political subdivision, or other interested person may appear at the hearing and be heard.
