Civil No. COMPLAINT
Plaintiff, the Estate of Alvina Geiger ("the Estate"), appears by and through its duly appointed and acting Personal Representative, Allan Geiger, who brings this action on behalf of the Estate and for its complaint against the above-named Defendants, states and alleges as follows:

1. The Personal Representative was appointed by the District Court of Sheridan County, in Case No. 42-2026-PR-00002, on April 15, 2026 and is authorized to prosecute actions

to recover, protect, and quiet title to property of the Estate. Certified letters of administration were issued on April 15, 2026, and remain in full force and effect.

2. Defendant William Axt ("Defendant 1") is deceased. Plaintiff is informed and believes, and on that basis alleges, that Defendant 1 died on or about an unknown date, and that Defendant 1's estate, if any, has or may claim an interest in the property described below.

3. Defendant Edna Axt ("Defendant 2") is deceased. Plaintiff is informed and believes, and on that basis alleges, that Defendant 1 died on or about an unknown date, and that Defendant 2's estate, if any, has or may claim an interest in the property described below.

4. Defendant Pearl Axt ("Defendant 3") is deceased. Plaintiff is informed and believes, and on that basis alleges, that Defendant 3 died on or about an unknown date, and that Defendant 3's estate, if any, has or may claim an interest in the property described below.

5. Defendant Leon Axt ("Defendant 4") is deceased. Plaintiff is informed and believes, and on that basis alleges, that Defendant 4 died on or about an unknown date, and that Defendant 4's estate, if any, has or may claim an interest in the property described below.

6. That this is an in rem action commenced by the Plaintiff to determine the rights of the parties in and to the following described lands situated in Sheridan County, North Dakota:

THE NW4 (21-147-77), SW4, SE4, (15-147-77). (hereinafter the "Subject Property"). At all relevant times, the Property has been situated in Sheridan County, North Dakota.

7. That this court has subject matter jurisdiction over this action pursuant to Chapters 32-17 and 32-23 of the North Dakota Century Code.

8. Decedent Alvina Geiger acquired title to the Property by quitclaim deed, recorded on December 12th, 1967, as Instrument No. 164330 in the Official Records of Sheridan County, North Dakota.

9. Decedent held title to the Property as tenants in common with Defendant

1, Defendant 2, Defendant 3 and Defendant 4, as reflected in the public record.

10. Decedent died on January 4, 2025, and a probate proceeding for the Estate is pending in the District Court of Sheridan County, in Case No. 42-2026-PR-00002, on April 15, 2026. The Property is an asset of the Estate and subject to administration.

11. Since the death of the Plaintiff, issues have arisen regarding claims or potential claims asserted or that may be asserted by or through the deceased defendants named herein, their estates, or their unknown heirs, devisees, legatees, grantees, creditors, successors, or assigns, which claims are adverse to Plaintiff's title.

12. Plaintiff is informed and believes, and on that basis alleges, that any such claims are without right and that the deceased defendants, their estates, and any unknown heirs, devisees, legatees, grantees, creditors, successors, or assigns have no valid estate, right, title, lien, or interest in or to the Property.

QUIET TITLE
13. That Plaintiff incorporates by reference Paragraphs 1-12, above, as though fully set forth herein.

14. This cause of action is brought pursuant to North Dakota Century Code § 32-17-12 and related provisions, to establish Plaintiff's title to the Property and to determine adverse claims.

15. Plaintiff holds the superior legal right to the Property as an asset of the Estate, by virtue of the chain of title described above and applicable probate law.

16. Defendants, and each of them, claim or may claim some estate, right, title, lien, or interest in the Property adverse to Plaintiff, which claims are without right and constitute a cloud on Plaintiff's title.

17. Plaintiff seeks a judicial declaration that Plaintiff's title is valid and that Defendants, and all persons claiming by, through, or under them, have no estate, right, title, lien, or interest in the Property, and that they be forever barred and enjoined from asserting any adverse claim thereto.
