The project consists of: grading, salvage aggregate surfacing, aggregate surface course, culvert replacements, erosion control, signing and incidentals.

SCRANTON CITY COUNCIL

**CALL TO ORDER:** The Scranton City Council met at city hall on Monday, November 10th, 2025. Mayor Jason Anderson called the meeting to order at 7:00 p.m. In attendance were Aldermen: Travis Teske, Brian Weber, John Pretzer, Ryan Schumacher; Auditor: Kari Ruggles; Visitor: Dean Pearson.

**PLEDGE OF ALLEGIANCE:** The pledge was said.

**APPROVAL OF MINUTES:** Brian Weber moved to approve the October minutes, John Pretzer second, roll call vote, MC.

**AGENDA APPROVAL:** Travis Teske moved to approve the agenda for November, Ryan Schumacher second, roll call vote, MC.

**FINANCIAL REPORTS:** Brian Weber moved to approve the financial reports for November 10th, 2025 for the city of \$1,110,042.42 and the Parkboard of \$12,493.14, Ryan Schumacher second, roll call vote, MC

**BILLS PRESENTED:** John Pretzer moved to pay all bills presented for October, Brian Weber second, roll call vote, MC.

**AUDITOR/PARKBOARD REPORT:** Past due water customers were discussed. Christmas In Murray Park is scheduled for November 30th instead of December 1st as there is an elementary concert on the 1st. Festivities will be held at the Community Center beginning at 5 pm with a chili supper and Santa.

**PWS REPORT:** We are still waiting for the water tower mixer to be wired in. There were some areas on the water tower that needed to be touched up after it was painted. Those touch ups have been done.

**UNFINISHED BUSINESS:** Brian Weber moved to raise the city sales tax from 1% to 2% with a maximum of \$50 per transaction, effective April 1st, 2026, John Pretzer second, roll call vote: Schumacher aye, Teske aye, Weber aye, Pretzer aye, MC. City sales tax is spent at the discretion of the city council and the increase will be used to balance the budget. Mindy Schumacher, County Auditor, has informed the council that the annual city tax levy can only increase by 3 percent each year.

**NEW BUSINESS:** Discussion was held regarding the city ordinances and possible changes that are being considered. Enforcing ordinances was also discussed. Numerical street signs need to be updated using actual numbers instead of letters. Dean Pearson attended the meeting regarding table top exercises that have been held in Bow-

man, Rhame & Scranton. Discussion was held regarding problem solving in the case of a city wide emergency.

**ADJOURN:** Ryan Schumacher moved to adjourn at 8:35pm, Brian Weber second, roll call vote, MC. The next city council meeting is scheduled for December 8th, 2025.
