- Review requirements of floodplain management in North Dakota based on changes to state law adopted in SB 2027 during the 2025 legislative session. Billings County will need to adopt a new floodplain management ordinance by May 31, 2026 in order to participate in the National Flood Insurance Program (NFIP).
