

# Youth agriculture takes the spotlight

## Dickinson State prepares to host area schools for FFA, 4-H event

Dickinson State University is getting ready to host one of the most-popular events on the Future Farmers of America and 4-H Clubs' calendars on Saturday, Feb. 7 that will see nearly every area school in attendance and more than 350 students participating. The Roughrider Judging Contest is typically hosted on the first Saturday in February, and this year's installment will allow them to get a look inside the refurbished and updated agriculture building at the campus and a view of the new rodeo arena that should bring a major boost to the area.

"It allows area kids and teams to come to Dickinson and go through a livestock judging contest and agronomy contest ... typically, this is the first contest of the season – at least here in the Southwest – that those kids will come to," said Dr. Chip

Polard, who serves as the university's Ag Club adviser. "I've spent six weeks or so kind of getting ready, and we put a contest together for them to judge live animals – cattle, sheep, pigs and a pen of goats – and from the livestock side they come and get an opportunity to evaluate pens of those animals and put them in order from best to worst.

"Then, they come back and study their notes and on three of those pens they have to give a set of oral reasons why they placed them in a particular order in front of a judge."

Among the opportunities the students will get to participate in include livestock judging, ag sales, and agronomy, while giving college students a chance to mentor the middle and high school students in the process. It also offers these individuals the chance to network with area agriculture representatives and potentially get a head start for

their future careers and education.

"We have a history, particularly here in the Southwest, of having very good livestock judging teams, and part of that is they start as Cloverbuds – even before they're old enough to be in junior 4-H – scared to death and soon they're working their way through the process," Polard said with a laugh. "By the time they become 16, 17, 18 years old, they're pretty good at it, but they've been doing it forever."

The students also are evaluated based on their abilities to judge agronomy in the form of plant species, weed species and be able to know what the various seeds look like, while also determining – through a green sample – the sorting and qualities of green and non-green components and whether there is foreign material or insects in the mix. Their grades also are evaluated by judges to determine the accuracy of their observations for wheat, barley, corn, soybeans and other crops.

"We're pretty excited, because we're trying

to build some of these young kids – and typically the agronomy contest has been primarily a n FFA event – but I think we have 12 junior 4-H members registered that are going to be in the agronomy contest, which is a big number for us," Polard said. "If we could get 18 or 20, I would be ecstatic, because it's just getting them started younger, so as they get older and transition from 4-H to FFA, they just get that

much better."

Ben Krebs, who is the New England FFA adviser, said the Roughrider Judging Contest is one of his students' favorite events, and he also is looking forward to seeing the improvements to the Ag Building and rodeo arena for the first time.

"I haven't been there since they got done renovating that place, so I'm excited to see how that all turned out," Krebs said. "It's put on by the Ag Club, so it's used as a leadership opportunity

for the collegiate club in prepping things and working with the younger kids. I think it's a good two-way street."
