2026 NDSU Feedlot School set for January 21-22 in Carrington

North Dakota State University's Carrington Research Extension Center will hold its annual NDSU Feedlot School on Jan. 21-22, 2026.

This intensive course is designed for cattle producers, feeders, backgrounders, feed industry personnel, animal health care suppliers and anyone interested in learning more about feedlot production, nutrition, waste management and marketing.

'Cattle feeding is a very competitive business," said Karl Hoppe, NDSU Extension livestock systems specialist at the Carrington Research Extension Center. "Making cattle feeding profitable is usually a result of doing many things right, not just one thing better."

The feedlot school helps identify areas for improvement, ranging from feed bunk management to health to business planning to mar-

'The regional cattle experts who teach at the school provide a good overview of management for North Dakota feeders," added Hoppe. "Their interaction with the participants continues for years after the school."

Local legend goes nationwide

After premiering in Bismarck and all across the state of North Dakota this past fall, "Hazel," a feature movie based on the legendary Hazel Miner, made its national digital premiere on Tuesday, Dec. 23.

According to a University of Mary press release, the movie, which was distributed by Samuel Goldwyn Films, was released on video-on-demand across Apple TV, Amazon, GooglePlay/YouTube Movies, Fandango-at-Home, Versant, Vubiquity and DirecTB/AT&T, with an exclusive streaming window on Angel Studios.

"Hazel's Heart" tells the true story of 16-year-old Hazel Miner, a farm girl from Center, N.D., whose heroic actions during a deadly 1920 blizzard became one of the state's most enduring survival stories. Originally developed under the title "Hazel," the name was updated ahead of the national

McKenzie County rejects solar farm

In a decisive meeting on Dec. 16, the McKenzie County Board of Commissioners voted unanimously to deny a permit for the Cattle Creek Solar Project, prioritizing a groundswell of local opposition over the developer's last-minute appeal for more time. The decision effectively halts the proposed \$280-million, 150-megawatt photovoltaic project, which was slated to encompass 853 acres in the Patent Gate area.

Before the vote, Eric Wedesky, Senior Project Developer for IBV Energy Partners, presented a formal request to "table" the decision until March 2026. Wedesky argued that the additional months would allow the company to further engage with neighbors, negotiate compensation packages and fund an escrow account for third-party engineering reviews.

Despite IBV's technical compliance the commissioners remained unmoved by the request for an extension. During the board's discussion, commissioners acknowledged that while IBV had worked diligently to "check the boxes" regarding ordinances and environmental studies, the project failed to win the most critical factor: public consent.

"What we're ultimately dealing with here is that we have a pretty tremendous public outcry and a unified opinion saying that we don't want this project here," stated commissioner Joel Brown.

He described the level of community resistance as "unprecedented" during his tenure. The board emphasized that their role as elected officials was to honor the will of their constituents, even if a project meets technical specifications

Minto native elected chief justice

Lisa K. Fair McEvers, a native of Minto, will become the first female chief justice of the North Dakota Supreme Court, commencing Jan. 1, 2026.

McEvers plays off the gender role, but recognizes it's a first and she is glad to take North Dakota off the list of states that have never had a female chief justice.

"It is an amazing honor and privilege to have the opportunity to serve in this capacity regardless of my gender," she said. North Dakota is only a handful of states that have not had a female chief justice.

McEvers was elected by more than an 80% majority when ballots were counted Dec. 10 in the election for chief justice of the Supreme Court.



The North Dakota Corn Utilization Council election for Eddy County will take place on Thursday, January 22, 2026, at 3:00 PM (CT) at the NDSU Extension office, 205 3rd St SE, in New Rockford, ND. Election will follow the Waterhemp Meeting.

ELECTION

A Voting Producer is a person who plants, or causes to be planted a Corn crop in which the person has an ownership interest, with the intent that upon maturity the crop will be harvested in the next available or immediately preceding growing season. Producers have to reside in Eddy County and have not requested a Corn refund during the preceding year.
