Subscription cost of \$750.00 for 50 cases will be shared by departments and paid through the non-departmental fund. Motion made by Meyer to approve contract, seconded by Hochhalter. Roll call vote - Meyer - aye, Hochhalter - aye, Zenker - aye. Motion carried.
Jason Schatz presented the final Plat of the Schatz' Third Subdivision. Motion made by Hochhalter and seconded by Zenker to approve final plat. Roll call voter - Meyer - nay, Hochhalter - aye, Zenker - aye. Motion carried.
Jason Albert requested changes to the Flood Plain Ordinance due to changes in North Dakota Century Code language. Meyer moved to accept the changes to the Ordinance, seconded by Hochhalter. Roll call vote - Meyer - aye, Hochhalter - aye, Zenker - aye. Motion carried.
Jacki Steinmetz, Director of Tax Equalization, informed the Board of changes to North

Dakota Century Code section 57-02-53, which requires notice of true and full value of each parcel of taxable property for the current and previous year. Delivery of such notice must be as least fifteen days before the meeting of the local board of equalization. Steinmetz stated she has sales information to enter. Meyer asked for clarification on farm residence exemption for mobile home owners. Auditor Meier stated the mobile home can be exempt if the owners also own the land upon which the mobile home is located, and the occupant otherwise qualifies for the exemption. Steinmetz said she will send the application for exemption to the mobile home owners in question.

John Sauber, Sauber Engineering met with the Board to discuss gravel prospecting and alternative procedures for locating and excavating gravel.

Motion made by Meyer and seconded by Hochhalter to advertise bid letting for graveling excavation and stockpiling. Roll call vote - Meyer - aye, Hochhalter - aye, Zenker - aye. Motion carried.

Motion made by Meyer and seconded by Hochhalter to hire Sauber Engineering for planning and application process for three road reshaping and graveling projects in 2026. Roll call vote - Meyer - aye, Hochhalter - aye, Zenker - aye. Motion carried.

Being no further business, Zenker adjourned meeting at 1:07 pm. FYI: next scheduled meetings will be February 4th and 18th, 2026. The Grant County Courthouse will be closed on February 16th, 2026 for Presidents Day.
