One aspect of the New Deal Dahners found interesting was the federal minimum wage it set and the abolishment of child labor. The New Deal did not fully end the Great Depression, World War II spending did, but it stabilized the economy, provided essential relief, and created lasting reforms like Social Security and increased labor rights.

At the state level, Dahners picked up on items needing improvement on her board before she heads to na-

tionals. "When I did my research the first time, it was very rough, every time now I have changed something or gone more in depth," she explains. Before heading to state, Dahners included the impact the New Deal had on North Dakota specifically.

Visiting the nation's capital is something Dahners and Stewart are eager to experience, both with a bucket list of places to explore. The Holocaust Museum is a must-see on both their lists, with the addition of the Lincoln Memorial and the Reflecting Pool.

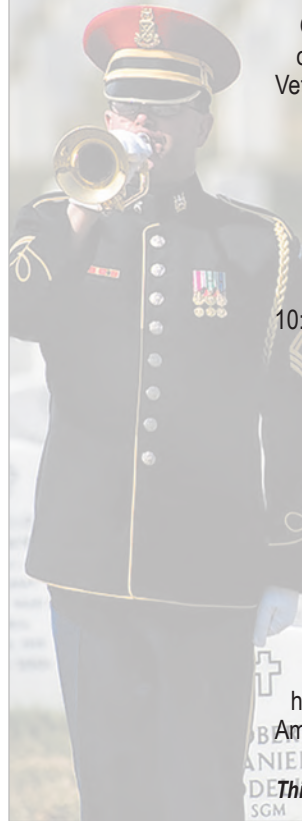
