their life a little bit better that's what gets me out of bed, because a lot of people did it for me."

As for her long-term goals as the new manager at West Plains Inc., Keller shared, "Well, one long-term goal, obviously, is to continue providing excellent customer service. Without our customers we wouldn't be here. It's going to come down to who's going to provide the best customer service. The customers can fire us just as quick as they hired us, right? We're going to do a lot of team building, because I really believe in that. I don't like silos at the dealership, because, you know, every department has a tendency to sit in their own silo. We're already busting those silos down, so that's been really good."

"We've had some opportunities in the service department with Scott Roberts taking the

reins there. I have full faith in Scott. We have a good group of techs. There's one that's young and a little green, but I have a lot of faith in that kid, too. We're going to change some culture and keep thanking the customers for walking through the door."

Roberts has 11 years of experience at West Plains, starting in the shop and becoming a road technician before his promotion to service manager. As far as any changes he'd make, Roberts said, "Just try to get our productivity up; try to be the best shop we can be. Try to take care of our customers with the people we have. We will take it one step at a time."

Keller wrapped up the interview by saying, "I am really grateful to be here, and really grateful for the community of Beach. I can tell that it's a good place to be."
