The June 3 reader was Golden Valley County Sheriff Dey Muckle. Sheriff Muckle read two books for the kids, the first being titled *Dinos Love Donuts* by Ben Okon.

After reading the title for this book, Sheriff Muckle made the comment, “You guys know who else likes donuts? The local cops!” and the kids burst out laughing.

The second book was *Have You Seen My Dinosaur* by Jon Suralg,

which told the story of a boy looking for his dinosaur while they were playing hide and seek.

The kids and Sheriff Muckle worked together to scan the pages and find the missing dinosaur.

After they finished reading, everyone slowly filtered out the door while Sheriff Muckle showed the kids his patrol vehicle and they eagerly climbed in the backseat.

Let me tell you, I have never seen a group of kids more eager to get arrested in my life. The kids finished story hour with a craft where they got to decorate their own donut.

When asked about her favorite part about story hour, Tescher responded, “Watching people interact with the kids and also getting the kids used to people in uniform.”

Tescher also shared new books the library has recently received.

## Stay or go?

The Beach City Council met on June 1, discussing a large tree, the Tourist Information Center and funding for the upcoming Shakespeare in the Park event.

In Public Works Superintendent Randy Dietz's report, he said that a resident, Jim Dykins, has a very large, tall and healthy tree by his property and he wants the city to remove it at the city's expense. Dietz urged that Dykins shouldn't have the tree removed because there's a chance that the tree could fall on his house and since it is about three feet wide, it would do significant damage if it did fall.

“If the tree was dead, I know we can take it down. That's not the issue,” Dietz said. “I don't believe a perfectly healthy tree needs to be pulled from the boulevard unless it's diseased.”

Because the tree is in the city's right of way, the tree belongs to the city. However, as of June 1, the city had yet to evaluate

the condition of the tree in order to determine whether the tree is deemed a hazard.

Additionally, the council shared that they don't think they have it in the budget to remove it. Estimated removal costs, on the low-end, would be about \$3,500.

In City Auditor Kim Gaugler's report, she shared that the Tourist Information Center has seen lots of visitors from various places this past month. Since May 18, there have been 602 visitors from Alaska, Florida, Idaho, Michigan, Oregon, Texas, Washington, Canada and Holland. Many of them requested information about Medora.

The council approved a \$750 funding for the Montana Shakespeare in the Parks group. They will be coming to the Golden Valley County Swimming Pool Park on June 29 at 6:30 p.m. to perform “The Merchant of Venice.”

The next Beach City Council meeting will be on June 18.
