
NOTICE OF FILING TO REVISE A PERMIT FOR SURFACE COAL MINING AND RECLAMATION OPERATIONS

The Coyote Creek Mining Company, L.L.C., 6502 17th Street SW, Zap, North Dakota 58580 has filed an application (Revision 14) to Permit NACC-1302 with the North Dakota Public Service Commission to revise surface coal mining activities. The permit revision revises the post-mining topography in portions of Sections 23, 24, 25, 26, and 36, T143N, R89W; Section 31, T143N, R88W; Section 6, T142N, R88W, of the Fifth Principal Meridian, Mercer County, North Dakota. This revision also contains updates to the following sections: introductory information, pre-mining land use, operations – general, surface water management, post-mining land use plans and topography, revegetation procedures, establishment and management, and vegetation assessment and success standards. The permit area is approximately four miles southwest of Beulah, North Dakota and approximately six miles south of Zap, North Dakota. The newspaper publication map shows the distance to the cities of Beulah and Zap, North Dakota, and the outline of the permit area.

CITY OF STANTON MEETING MINUTES

January 12, 2026
Mayor Sayler called the city regular meeting to order at 6:30 p.m. at the City Hall with the following members present: Kelly, Cole, Babb and Neumiller. Present were Public Works Supervisor, Chapman, Auditor Braithwaite, Attorney Solem. Also present were J. Summers, K. Thieling, Deputy Doll and K. Thernes. Moved by Cole, seconded by Kelly approving the minutes of December 8th, 2025 City Council regular meetings. Roll call vote: All members voted aye, carried. Moved by Cole, seconded by Kelly approving the November 2025 Financial Reports submitted by Auditor Braithwaite. Roll call vote: All members voted aye, carried. Moved by Kelly, seconded by Babb approving the pay \$96.04 for Thieling's water usage at 201 Selmes Avenue due to someone turning the curb stop back on. Roll call vote: All members voted aye, carried. Mayor Sayler asked Chapman to inspect the Stanton Welcome Signs and see what can be done to repair the signs. Chapman will look to see if the signs could be repaired or they need to be replaced. If they need to be replaced, he will get a quote at the next meeting. Moved by Cole, seconded by Neumiller approving the 2026 Dakota Pump & Control Annual Inspection agreement. Roll call vote: All members voted aye, carried. Moved by Neumiller, seconded by Cole approving the Joint Powers and Election Agreement with Mercer County Courthouse. Roll call vote: All members voted

aye, carried. Thieling asked the council about her flooded basement and who should be responsible for the damage which was caused by an unknown individual turning the curb stop back on. After some discussion, attorney Solem advised Thieling to file with the Sheriff's department. He also stated that the city was not liable for the damage nor could be held responsible. Thieling could submit a complaint with Auditor Braithwaite to file with NDIF if Thieling wanted to try that route. Councilman Cole informed that in his absent, Binder will be communicating with Chapman in regards of updating the kitchen sinks at the civic center. Moved by Neumiller, seconded by Kelly approving the agreement with Game & Fish for the fish cleaning station with the effective date from January 1st, 2026 – December 31, 2030. The agreement will renew automatically going forward. The agreement stated that the Game & Fish will be financially responsible for any cost/work for the fish cleaning station maintenance. Roll call vote: All members voted aye, carried. Moved by Cole, seconded by Neumiller approving Attorney Solem to make changes in the ordinance within the service disconnections from the fourth Tuesday of that month or the 15th of the following month. Council also asked Attorney Solem about parking trailers on the streets. After a brief discussion, the council still requested an ordinance for prohibiting trailers, campers and other similar classifications from parking on

the streets from October – April. This ordinance was previously discussed and approved in the Fall of 2025.
