The Napoleon/Gackle-Streeter boys' golf team finished in 4th place out of 9 teams with 55 individuals entered in the Val-

ley City Invite on Mon., May 11. NGS head coach Jamison Fettig and his squad were in a dog fight, as the first four teams were within 22 strokes of each other. Host, Valley City claimed team honors with a 334 while New Rockford-Sheyenne placed second with 352, Edgeley-Kulm was third with 355 to edge the Imperials by one stroke, who came in fourth with a 356. Grigg-Midkota came in fifth place with a 373.
