PUBLIC HEARING NOTICE NORTH DAKOTA HOUSING FINANCE AGENCY PROPOSED QUALIFIED ALLOCATION PLANS UNDER THE 2027 LOW INCOME HOUSING TAX CREDIT PROGRAM, 2026 NATIONAL HOUSING TRUST FUND, 2026 HOME INVESTMENT PARTNERSHIPS PROGRAM, AND 2026 HOUSING INCENTIVE FUND.

North Dakota Housing Finance Agency (NDHFA) will hold a Public Hearing for its proposed Qualified Allocation Plans (Plan) for the 2027 Low Income Housing Tax Credit Program, 2026 National Housing Trust Fund, 2026 HOME Investment Partnerships Program, and 2026 Housing Incentive Fund on March 6, 2026.

Each plan sets forth the procedures and criteria to which NDHFA will adhere in allocating financing to multi-family affordable housing projects in each respective program during the September 2026 application round.

The hearings are for interested parties to provide either written or oral comments regarding the proposed plans. Persons who do not attend the hearings may submit written comments by 5:00 p.m., CT, on March 4, 2026.
