The Barnes County Commission met in regular session on Tuesday, July 7, 2026 with Bill Carlblom, Mike Schwehr, Vicky Lovell, Pete Paulson, and Shawn Olason. Chairman Bill Carlblom called the meeting to order at 8:00 a.m., roll call was taken, the Pledge of Allegiance was recited, and the agenda was reviewed.

Pete Paulson moved to approve the agenda as presented. Mike Schwehr seconded the motion. Motion carried with all members voting aye.

Public Comments

No requests received.

Auditors Office

Shawn Olason moved to approve the June 16, 2026 minutes as presented. Vicky Lovell seconded the motion.

Motion carried upon roll call vote with all members voting aye. HVAC funding was discussed. We were rewarded with \$56,000 for the Court Facilities Improvement Advisory grant for the HVAC project. We will ask for a progress report on the HVAC construction project.

Commission Discussion

Pete Paulson gave an update on Veteran Service Office. The van bumper has been repaired. The airport sold a payload and will be purchasing a used one from General Equipment. The pancake breakfast usually held during Rally in the Valley fell through. The Economic Development has a small feed processing plant looking for a site. Some possible sites were toured. He sat on the canvassing board for the 2026 primary election. Shawn Olason attended the Social Service meeting. The workers are working a forced overtime to catch up on overload cases. Currently, they are fully staffed. Shawn will bring up the budget for wage increase for 2027 at the next Water Resource meeting. Mike Schwehr gave an update on CCHD activity. They are approved for a grant that is shared with Stutsman County. They are working on the privacy counter project in the front office. They are advertising for a Home Health Coordinator. Miller Elevator will be vacating their office located on the top floor. Vicky Lovell attended the SCRDC meeting and reminded everyone of the grant programs that are available. The highway department held interviews for road operators. HUD had their audit with no flaws. Departmental budget meetings will be held Tuesday, July 14th and Monday,

July 20th beginning at 5:00 pm.
