

Night Hawk track & field gaining momentum

The Hettinger-Scranton Night Hawks continued a busy and productive stretch of the track and field season, turning in strong performances at the Lemmon Invitational on Saturday, April 25, after also posting solid results earlier in the week at the Holliger Twilight Meet on April 21.

The Night Hawks were highlighted in Lemmon by several event champions and

top-three finishes, showing balance in sprints, relays, jumps and field events.

Leading the boys team was sophomore Robert Morris, who captured the high jump title by clearing 5-foot-8. Morris also added a fifth-place finish in the long jump at 18-2 and placed fifth in the 100-meter dash in 12.99 seconds.

Tatum Campbell continued his standout

season by winning the 300-meter hurdles in 50.44 seconds. Campbell also placed second in the triple jump with a personal-best leap of 34-11 1/2 and took ninth in the long jump.

Linwood Perkins added a runner-up finish in the high jump at 5-2, placed sixth in the long jump at 17-9 and finished eighth in the 200-meter dash in 27.07.

The Night Hawks' boys 4x100 relay team of Jake Zimmermann, Asher Hamilde, Perkins and Morris raced to a second-place finish in 50.10.

In the throwing events, Jace Palczewski recorded a pair of personal bests, placing 10th in discus at 85-0 and 18th in shot put at 25-8 1/4. Brodie Sott finished 13th in shot put and 13th in javelin.

The Hettinger-Scranton

girls also made plenty of noise in Lemmon, led by sophomore standout Acalia Olson, who won the javelin with a throw of 98-1 while taking second in both shot put (32-8 1/2) and discus (94-1), with both marks personal bests.

The Night Hawks also shined in relays, finishing second in the sprint medley relay. Sophi Gonder, Anna LeFebre, Rachel Ranum and Delaynah Nagel combined for a time of 5:03.16. The girls added third-place finishes in both the 4x100 relay (57.26) and 4x400 relay (4:42.08).

Individually, Anna LeFebre placed fifth in the 100-meter dash in 14.39 and 10th in the 200. Rachel Ranum was fifth in the 200-meter dash with a personal-best 29.68.

Claire Kennedy and Addy Glines each

posted personal bests in the 400-meter dash, finishing fifth and sixth respectively in 1:12.18 and 1:12.44. Sawyer Weber added personal bests in both the 400 and 800 meters.

Kiley Mausehund placed fourth in the long jump at 13-9, while Delaynah Nagel was sixth and Sophi Gonder eighth.

Earlier in the week at the Holliger Twilight Meet, Campbell had one of the top efforts for the boys, finishing second in the 400 meters with a personal-best 59.52. Liam Kennedy also posted a personal-best 34-1 in shot put for seventh place.

The Night Hawk girls were especially strong at Holliger, where Jaeda Jensen won the 400 meters in a personal-best 1:01.24 and added fifth in the 200 with another

personal best. Sam Salazar placed second in the 100-meter hurdles in a personal-best 17.62.

Katie Buckmier ran to fifth in the 100 meters with a personal-best 14.06, while Anna LeFebre placed seventh. Allison Skogen and Salazar also scored in the sprints.

The girls relay teams continued to excel at Holliger, placing third in the 4x400 relay, fourth in the 4x200 relay and fifth in the 4x100 relay.

Olson was again a force in the field events, placing second in javelin with a throw of 104-8, third in shot put and fourth in discus.

With multiple personal records and strong finishes in back-to-back meets, the Night Hawks appear to be gaining momentum as the season heads deeper into the spring schedule.
