BOARD MINUTES FLASHER PUBLIC SCHOOL DISTRICT NO. 39 REGULAR MEETING – JUNE 15, 2026

The regular meeting of the board was called to order on the above date at 7:05 P.M. by President Travis Rossow with the following present: Directors Sherry Schmidt, Nancy Malm, Andrea Fleck, Joe Fleck, Duric Hoff, Supt. JR Wilson, and Business Manager Joyce Miller. Director CJ Boldt was unable to attend. Visitors were Sam Poland and Tiffany

Hoff.

Minutes of the regular meeting of May 12, 2026 were presented. Motion by Schmidt, second by J. Fleck, to approve the minutes. Motion carried with all voting aye.

Funds were presented and reviewed by the board. Motion by A. Fleck, second by Malm, to approve reports as presented. Motion carried with all voting aye.

Transportation: Bus driver meeting will be August 12. Discussion on selling small buses by sealed bids and also possible ideas on what to do if

bus route drivers are not hired.
