### CITY OF FORMAN, NORTH DAKOTA REGULAR CITY COUNCIL MEETING JANUARY 13TH, 2026

The regular City Council meeting was called to order at 6:00 PM by Mayor Kevin Bopp. Present were council members, Luke Anderson, Mark Wyckoff, and John Stenvold. Also attending were Mayor Kevin Bopp, City Auditor Alicia Thompson, City Superintendent Donavon Hajek, City Coordinator Sara Dux, and City Attorney Lyle Bopp.

Guest/ Public Comments: Ottetail Power and Mike Keiper

All stood for the pledge of allegiance.

A motion was made by Mark Wyckoff and seconded by John Stenvold to approve the agenda for the regular city council meeting. Motion carried.

Operation manager Dale Rubish was present from Ottetail power with the 20-year agreement to allow infrastructure on our right aways. Luke Anderson made a motion to approve the first reading of Otter Tail Power ordinance granting Otter Tail Power access to the City of Forman. John Stenvold seconded that motion. Motion carried.

Mike Keiper was present on behalf of the Forman Park Board to discuss the sand volleyball court at the fairgrounds.

Luke Anderson made a motion that the Park Board put a Sand volleyball Court at the Sargent County Fair grounds, Mark Wyckoff seconded that motion. Motion carried.

Mark Wyckoff made a motion to approve the November 11th city council meeting minutes. Luke Anderson seconded that motion. Motion carried.

Sheriff Report- Sheriff Paeper was present, said it's been an average month. He spoke about some drug activity that has been going on in the county and working with the Drug Task Force. Also, gave a big thank you to our city Superintendent Donavon Hajek for bringing gravel down to a local fire.

City Superintendent Donavon Hajek provided an update on recent maintenance activities and ongoing issues. He reported that the garbage truck continues to experience mechanical problems. The new tires for the payloader have arrived. The city will be looking for summer help to assist with mowing around town. Donavon and JT are currently studying for upcoming certification tests.

Luke Anderson made a motion to approve the resolution for Sargent County emergency Management and John Stenvold seconded it. Motion carried.

City Coordinators Report- gave an update on the recent grant she is working on. She also shared the consistent increase in number of patrons for both the Library and Food pantry in the last year.

Luke Anderson made a motion to transfer 2000.00 from Forman Improvement Funds to help cover expenses for the libraries 2026 payroll.

John Stenvold made a motion to pay EDC Coordinator a salary of 400.00 a month and \$25.00 per hour for extra project work on a contract basis. Mark Wyckoff seconded that motion. Motion carried.

A motion was made by Luke Anderson and seconded by Mark Wyckoff to approve an extension for 1 year on Glen and Leah Schulz Renaissance Zone Tax Credit, giving a full 5 years on the tax credit. Years 2026-2030. Motion carried.

A motion was made by Luke Anderson to work with Brittnay Hatting from PLLP law with annexing, zoning and future city expansions. Mark Wyckoff seconded that motion. Motion carried.

A motion was made by John Stenvold and seconded by Mark Wyckoff to approve the City Auditors' report, delinquency report and payment of the bills. Motion carried.

## Two men sentenced in theft of cemetery bell

Two men admitted stealing a 113-year-old bell from White Stone Hill Cemetery destroying it and selling it for scrap in September. The 400-pound bell was valued at \$40,000.

Paul Vincent, 39, pleaded guilty to theft and said he was under the influence of methamphetamine at the time. He admitted selling the bell for about \$1,500. A Sargent County judge sentenced him to five years in prison on Feb 12.

Derek Sims, 36, also pleaded guilty to theft, saying he sold parts of the bell for \$400. His plea deal calls for a one-year prison term, though the judge will decide whether to accept the deal at sentencing in April.

Both men said they regretted their actions

The cemetery association will provide the judge at the April hearing with the cost to replace the bell, estimated at \$50,000. Both men will be responsible for the expense.
