Notice of Public Hearing

The City of Steele has received a Community Development Block Grant (CDBG) from the State of North Dakota Division of Community Services (DSC). CDBG funds are intended to provide decent housing, suitable living environments and economic opportunities, principally for low/very low-income persons through rehabilitation and preservation, economic/job development and public facilities improvement.

The project and funding level considered was \$153,500.00 for their CDBG Multi-Family Housing Rehab (Prairie View Housing) project.

It is estimated that approximately 100% of the funds benefited low/very low-income persons.

Displacement of neighborhood persons or businesses did not occur, and no housing units were demolished or converted as a result of the above-mentioned projects.

A public hearing will be held on June 8th, 2026 at 6:30 p.m., at the Steele City Office, 103 West Broadway, Steele, ND 58482 to

obtain citizen views and to respond to proposals and questions related to the performance of The City of Steele in carrying out its community development responsibilities. Written comments are also welcome and must be received at the address below by the close of the public hearing. Oral and written comments will be considered to enhance the City of Steele in carrying out its -community development responsibilities. APPLICATION FOR APPROPRIATION OF WATER FROM SURFACE WATER

TAKE NOTICE that SUBART, AARON & JESSI, ROBINSON, ND, have submitted Water Permit Application No. 7462 to the North Dakota Department of Water Resources for a permit to divert and appropriate water from an unnamed pond.

The application requests an annual appropriation of 375.44 acre-feet of water for Irrigation use at a pumping rate of 3,200 gallons per minute, utilizing point(s) of diversion located in the E1/2 NE1/4 of Sec. 13, T. 141 N., R. 072 W., Kidder County, for the purpose of irrigating 131.55 acres in the NE1/4, 1.87 acres in the NW1/4, 109.35 acres in the SW1/4, and 132.67 acres in the SE1/4 all of Sec. 18, T. 141 N., R. 071 W., Kidder County.

TAKE NOTICE that written comments regarding the proposed appropriation must be filed in the Department of Water Resources, 1200 Memorial Highway, Bismarck, North Dakota 58504-5262, by 5 o'clock p.m., on the 12 day of June 2026. The Department of Water Resources shall consider all written comments received and prepare a recommended decision which will be provided to the applicant and any person who filed written comments. Those persons may file additional comments with the Department of Water Resources, request an adjudicative proceeding on the application, or both.
