



**North Dakota Students to Demonstrate Civic Learning at Public We The People Event in Bismarck**

BISMARCK, ND; May 20, 2026 — The Study ND will host We The People in Action: A Live

Student Hearing and Community Conversation on Monday, June 8, 2026, from 5:30 to 6:30 PM at the Basin Electric Auditorium, NECE, Bismarck State College, 1200 College Drive, Bismarck.

The free public event will take place during the We The People Summer Teacher Institute, which brings North Dakota teachers to Bismarck from June 7–10 for professional development focused on constitutional education, civic knowledge, and classroom practice and is supported in part by a grant from the North Dakota Department of Public Instruction.

The evening will feature students from the 2026 We The People North Dakota State Championship team participating in a live, simulated congressional hearing. Students will present and defend their constitutional reasoning before a panel of scholars and educators, giving the public a

firsthand look at what high-quality civic education can look like in practice.

The student hearing will focus on James Madison’s warning that the “greatest danger” to liberty may come not only from government, but from “the body of the people, operating by the majority against the minority.” Students will consider how the Bill of Rights protects minorities, whether individual rights should ever be limited by the will of the majority, and which rights most need protection today.

Following the hearing, Aruna Patel, Vice President and Chief Program Officer at the Center for Civic Education, will reflect on the broader impact of the We The People program, including how it supports teachers, challenges students, and contributes to stronger, more connected communities. A short audience Q&A will follow.

“This event gives North Dakotans a chance to see students learning the real work of democracy through simulated action,” said Brenna Gerhardt, Executive Director of The Study ND. “They are studying the Constitution, thinking carefully about individual rights and civic responsibility, and practicing the habits of thoughtful citizenship.” Gerhardt concluded, “At a time when civic education matters deeply, we are proud to support teachers and students doing this work across our state and learning their roles as future civic leaders.”

Members of the public, educators, legislators, civic leaders, parents, students, and community members are encouraged to attend.
